Mr. BENNET introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

To help local educational agencies reduce chronic absenteeism and create safe learning environments in public elementary schools and secondary schools, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Keep Kids in School
5 Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1 (1) ESEA TERMS.—The terms “elementary
2 school”, “local educational agency”, “secondary
3 school”, and “State educational agency” have the
4 meanings given those terms in section 8101 of the
5 Elementary and Secondary Education Act of 1965
6 (20 U.S.C. 7801).

7 (2) CHRONIC ABSENTEEISM.—The term
8 “chronic absenteeism” means students at a public
9 elementary school or secondary school who are ab-
10 sent, for any excused or unexcused reason, for 10
11 percent or more of the days for which the student
12 is enrolled in a public school during a school year.

13 (3) SECRETARY.—The term “Secretary” means
14 the Secretary of Education.

15 (4) STATE.—The term “State” means each of
16 the 50 States of the United States, the District of
17 Columbia, the Commonwealth of Puerto Rico, Amer-
18 ican Samoa, the Commonwealth of the Northern
19 Mariana Islands, Guam, and the United States Vir-
20 gin Islands.

21 **SEC. 3. GRANT PROGRAM.**

22 (a) PROGRAM AUTHORIZED.—

23 (1) IN GENERAL.—From amounts made avail-
24 able to carry out this section, the Secretary shall
25 award grants to State educational agencies to enable

1 the State educational agencies to award subgrants to
2 local educational agencies to provide assistance to
3 public elementary schools and secondary schools
4 served by the local educational agencies to reduce
5 the chronic absenteeism rate at the schools and fos-
6 ter safe learning environments.

7 (2) PREFERENCE.—In awarding grants to
8 State educational agencies under paragraph (1), the
9 Secretary shall give preference to States with high
10 rates of chronic absenteeism or those serving the
11 most vulnerable student populations.

12 (b) APPLICATIONS.—

13 (1) STATE EDUCATIONAL AGENCIES.—A State
14 educational agency desiring a grant under this sec-
15 tion shall submit to the Secretary an application at
16 such time, in such manner, and containing such in-
17 formation as the Secretary may require.

18 (2) LOCAL EDUCATIONAL AGENCIES.—A local
19 educational agency desiring a subgrant under this
20 section shall submit to the State educational agency
21 in the State in which the local educational agency is
22 located an application at such time, in such manner,
23 and containing such information as the State edu-
24 cational agency may require.

25 (c) USE OF FUNDS.—

1 (1) BY STATES.—A State educational agency
2 receiving a grant under this section shall use the
3 grant funds to award subgrants to local educational
4 agencies in the State.

5 (2) BY LOCAL EDUCATIONAL AGENCIES.—A
6 local educational agency receiving a subgrant under
7 this section shall use subgrant funds to reduce
8 chronic absenteeism rates and to create safe learning
9 environments in public elementary schools and sec-
10 ondary schools served by the local educational agen-
11 cy. Such activities may include—

12 (A) hiring additional counselors, mental
13 health professionals, social workers, or family li-
14 aisons;

15 (B) providing stipends to teachers to per-
16 form home visits for students who are chron-
17 ically absent;

18 (C) supporting programming to address
19 chronic absenteeism and to improve safety in
20 learning environments;

21 (D) transportation costs, such as buses;

22 (E) research and data collection so schools
23 and local educational agencies can track absen-
24 teeism rates, patterns, and root causes through-
25 out the school year; or

1 (F) other activities or methods that have
2 been shown to reduce the chronic absenteeism
3 rate.

4 (d) REPORTS.—Not later than 3 years after the date
5 a local educational agency receives a subgrant under this
6 section, the local educational agency shall prepare and
7 submit to the State educational agency a report regarding
8 the impact of the subgrant funds and whether each of the
9 elementary schools or secondary schools supported under
10 the subgrant reduced their chronic absenteeism rate. The
11 State educational agency shall submit reports received
12 from local educational agencies to the Secretary.

13 **SEC. 4. STUDY REGARDING CHRONIC ABSENTEEISM AND**
14 **SAFE LEARNING ENVIRONMENTS.**

15 (a) STUDY.—The Comptroller General of the United
16 States shall conduct a study on chronic absenteeism and
17 safety in learning environments in public elementary
18 schools and secondary schools of the United States.

19 (b) CONTENTS OF STUDY.—In carrying out the study
20 under subsection (a), the Comptroller General shall exam-
21 ine chronic absenteeism and research the extent to which
22 evidence-based interventions can reduce chronic absentee-
23 ism rates and improve student achievement and student
24 well-being.

1 (c) REPORT.—Not later than 1 year after the date
2 of enactment of this Act, the Comptroller General shall
3 prepare and submit a report regarding the study con-
4 ducted under subsection (a) and the conclusions and rec-
5 ommendations generated from the study to the Committee
6 on Health, Education, Labor, and Pensions of the Senate,
7 the Committee on Education and Workforce of the House
8 of Representatives, and the Secretary.
