Subpart 541.5—Solicitation Provisions and Contract Clauses

541.501 Contract clauses (FAR DEVIATION).

(a) *FAR deviation.* GSA has a deviation from FAR 52.232–19 that allows use of the clause at 552.241–70 in lieu of the FAR clause at 52.232–19. Insert the clause at 552.241–70, Availability of Funds for the Next Fiscal Year or Quarter, in lieu of the FAR clause at 52.232–19, in all utility acquisitions.

(b) *Utility services.* Insert the clause at 541.501(b), Disputes (Utility Contracts), in solicitations and contracts for utility services subject to the jurisdiction and regulation of a utility rate commission.

Insert the clause at 552.242–70, Status Report of Orders and Shipments, in solicitations and contracts when a requirements or indefinite-quantity contract for Stock or Special Order Program items is contemplated. The

clause may be used in indefinite-delivery definite-quantity contracts for Stock or Special Order Program items when close monitoring is necessary because numerous shipments are involved.
