OMNIBUS CIVILIAN SCIENCE AUTHORIZATION ACT

Committee on Rules: Granted, by voice vote, an open rule providing 1 hour of debate on H.R. 2405, Omnibus Civilian Science Authorization Act of 1995. The rule provides that the bill be considered by title rather than by section and that the first section and each title be considered as read. The rule provides for the automatic adoption of an amendment striking section 304(b)(3), relating to rulemaking activities by the Department of Energy. The rule accords priority in recognition to Members who have preprinted their amendments in the CONGRESSIONAL RECORD. Finally, the rule provides one motion to recommit, with or without instructions. Testimony was heard from Representatives Ehlers and Brown of California.

CONFERENCE REPORT—AGRICULTURE APPROPRIATIONS

Committee on Rules: Granted, by voice vote, a rule waiving points of order against the conference report to accompany H.R. 1976, making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Programs for the fiscal year ending September 30, 1996, and against its consideration. Testimony was heard for Representative Skeen.
