

amendment or a division of the question in the House or Committee of the Whole, and which shall be debatable for 20-minutes. The rule waives all points of order against the en bloc amendments.

The rule authorizes the Chairman of the Committee of the Whole to postpone consideration of a request for a recorded vote on any amendment and to reduce to 5-minutes the time for voting after the first of a series of votes.

The Chairman of the Committee of the Whole is also authorized to recognize for consideration of any amendment printed in the report out of the order in which printed but not sooner than one hour after the chairman of the National Security Committee or a designee announces from the floor a request to that effect.

The rule authorizes the chairman of the National Security Committee to offer an amendment not printed in the report to reconcile spending levels of bill with the final defense spending level contained in the conference report on the budget resolution, which shall be considered as read, shall not be subject to amendment or to a demand for a division of the question, and which shall be debatable for 10-minutes equally divided between the chairman and ranking minority member of the National Security Committee.

Finally, the rule provides for one motion to recommit, with or without instructions.

Record is available as an online database through *GPO Access*, a service of the U.S. Government Printing Office. The online database is updated each day the Congressional Record is published. The database includes both text and graphics from the beginning of the 103d Congress, 2d Session (January 1994) forward. It is available on a Wide Area Information Server (WAIS) through the Internet and via asynchronous dial-in. The annual subscription fee for a single workstation is \$375. Six month subscriptions are available for \$200 and one month of access can be purchased for \$35. Discounts are available for multiple-workstation subscriptions. To subscribe, Internet users should telnet swais.access.gpo.gov and login as newuser (all lower case); no password is required. Dial in users should use communications software and modem to call (202) 512-1661 and login as swais (all lower case); no password is required; at the second login prompt, login as newuser (all lower case); no password is required. Follow the instructions on the screen to register for a subscription for the Congressional Record Online via *GPO Access*.
