

MESSAGE FROM THE SENATE

A message from the Senate by Mr. Lundregan, one of its clerks, announced that the Senate has passed without amendments bill and a concurrent resolution of the House of the following titles:

H.R. 3218. An act to amend title 31, United States Code, to prohibit the appearance of Social Security account numbers on or through unopened mailings of checks or other drafts issued on public money in the

Treasury. H. Con. Res. 396. Concurrent resolution celebrating the birth of James Madison and his contribution to the Nation.

The message also announced that the Senate agrees to the amendment of the House to the amendment of the Senate to the bill (H.R. 1651) "An Act to amend the Fishermen's Protective Act of 1967 to extend the period during which reimbursement may be provided to owners of United States fishing vessels for costs incurred when such a vessel is seized and detained by a foreign country, and for other purposes.

The message also announced that the Senate has passed bills and a concurrent resolution of the following titles in which the concurrence of the House is requested:

S. 783. An act to limit access to body armor by violent felons and to facilitate the donation of Federal surplus body armor to State and local law enforcement agencies.

S. 1898. An act to provide protection against the risks to the public that are inherent in the interstate transportation of

violent prisoners. S. 2508. An act to amend the Colorado Ute Indian Water Rights Settlement Act of 1988 to provide for a final settlement of the claims of the Colorado Ute Indian Tribes, and for other purposes.

S. 3137. An act to establish a commission to commemorate the 250th anniversary of

the birth of James Madison.

S. 3239. An act to amend the Immigration and Nationality Act to provide special immigrant status for certain United Sates international broadcasting employees.
