NEW PUBLIC LAWS

S. 313, to amend the Federal Food, Drug, and Cosmetic Act to establish a program of fees relating to animal drugs. Signed on November 18, 2003. (Public Law 108–130).

H.R. 274, to authorize the Secretary of the Interior to acquire the property in Cecil County, Maryland, known as Garrett Island for inclusion in the Blackwater National Wildlife Refuge. Signed on November 22, 2003. (Public Law 108–131).

H.R. 2559, making appropriations for military construction, family housing, and base realignment and closure for the Department of Defense for the fiscal year ending September 30, 2004. Signed on November 22, 2003. (Public Law 108–132).

H.R. 3054, to amend the Policemen and Firemen's Retirement and Disability Act to permit mili-

tary service previously performed by members and former members of the Metropolitan Police Department of the District of Columbia, the Fire Department of the District of Columbia, the United States Park Police, and the United States Secret Service to count as creditable service for purposes of calculating retirement annuities payable to such members upon payment of a contribution by such members. Signed on November 22, 2003. (Public Law 108–133).

H.R. 3232, to reauthorize certain school lunch and child nutrition programs through March 31, 2004. Signed on November 22, 2003. (Public Law 108–134).

H.J. Res. 79, making further continuing appropriations for the fiscal year 2004. Signed on November 22, 2003. (Public Law 108–135).
