## MOTION TO CLOSE CONFERENCE COMMITTEE MEETINGS ON H.R. 4200, NATIONAL DEFENSE AUTHORIZATION ACT FOR FISCAL YEAR 2005, WHEN CLASSIFIED NATIONAL SECURITY INFORMATION IS UNDER CONSIDERATION

Mr. SAXTON. Mr. Speaker, pursuant to clause 12 of rule XX, I move that the meetings of the conference between the House and the Senate on H.R. 4200, to authorize appropriations for fiscal year 2005 for military activities of the Department of Defense for military construction and for defense activities of the Department of Energy to prescribe personnel strengths for such fiscal year for the armed forces, and for other purposes, be closed to the public at such times as classified national security information may be breached, provided that any sitting Member of the Congress shall be entitled to attend any meeting of the conference.
