Program for Tuesday: Consideration of the following suspensions: (1) H. Res. 1307—Honoring the National

Science Foundation for 60 years of service to the Nation; (2) H. Res. 1213—Recognizing the need to improve the participation and performance of America's students in Science, Technology, Engineering, and Mathematics (STEM) fields, supporting the ideals of National Lab Day; (3) H. Res. 1310—Recognizing the 50th anniversary of the laser; (4) H. Res. 1231—Celebrating the 50th anniversary of the United States Television Infrared Observation Satellite, the world's first meteorological satellite, launched by the National Aeronautics and Space Administration on April 1, 1960, and fulfilling the promise of President Eisenhower to all nations of the world to promote the peaceful use of space for the benefit of all mankind; (5) H. Res. 1269—Commemorating the 400th anniversary of the first use of the telescope for astronomical observation by the Italian scientist Galileo Galilei; (6) H.R. 24—To redesignate the Department of the Navy as the Department of the Navy and Marine Corps; and (7) H. Res. 1132—Honoring the USS *New Mexico* as the sixth *Virginia*-class submarine commissioned by the U.S. Navy to protect and defend the United States.
