'I have cried, pained, and hoped; but most of all, I have lived times others would say were best forgotten.

'At least someday I will be able to say that I was proud of what I was, a soldier."

This is their birthday, the United States Army.

Mr. FALEOMAVAEGA, Mr. Speaker, I rise today in strong support of H. Con. Res. 286, celebrating the 235th birthday of the United States Army.

First, I would like to thank Chairman Skel-TON and Ranking Member McKEON of the Committee on Armed Services for bringing the resolution to the floor today. I also want to commend my good friend, Congressman CHET EDWARDS of Texas, for introducing this resolution as well as all of the other cosponsors for their rapid and strong support.

The freedoms that this great country was built on were not formed out of peace and diplomacy, but out of necessity for war. The United States Army has ensured the safety and continuance of the freedoms won since the Revolutionary War that declared our independence from Great Britain. Our United States military today is the strongest and fiercest volunteer force dedicated to protecting and defending our great nation. For this reason I would like to recognize all U.S. military personnel serving in our homeland and throughout the world.

For their service, valor and commitment, we must honor the United States Army. I urge my colleagues to pass H. Con. Res. 286.
