THE SKILLS ACT

(Ms. FOXX asked and was given permission to address the House for 1 minute.)

Ms. FOXX. Mr. Speaker, today the President called on Congress to take action to help put Americans back to work. Almost 9 months ago, the House passed H.R. 803, the SKILLS Act, with bipartisan support.
