MORNING-HOUR DEBATE

The SPEAKER pro tempore. Pursuant to the order of the House of January 3, 2017, the Chair will now recognize Members from lists submitted by the majority and minority leaders for morning-hour debate.

KANSANS HELPING FELLOW AMERICANS

The SPEAKER pro tempore. The Chair recognizes the gentleman from Kansas (Mr. MARSHALL) for 5 minutes.

Mr. MARSHALL. Mr. Speaker, I rise today to acknowledge and speak in support of my friends in Texas and Florida who are currently fighting and recovering from Hurricanes Harvey and Irma. While my thoughts and prayers go out to all those affected, I am also reminded of the courage and resilience Americans display in these trying times. I am especially proud of my

State of Kansas' National Guard, who has assembled and are currently assisting those affected.

Airmen in the 184th Intelligence Wing out of McConnell Air Force Base, Wichita, Kansas, are currently conducting incident awareness and assessment activities in both Texas and Florida. They are compiling information by analyzing video footage and imagery of the affected areas, pinpointing where immediate assistance is required.

Additionally, soldiers from the 69th Troop Command in Topeka are also advising senior National Guard leaders to ensure the National Guard is successful in their response efforts and critical information is effectively communicated to the public.

I am incredibly proud of the National Guard and all Kansans who are currently helping our neighbors in Florida and Texas in multiple capacities. It is incredibly empowering to watch Americans come together during these trying times and lend a hand to the most in need.

EMERGENCY AID TO AMERICAN SURVIVORS OF HURRICANES IRMA AND JOSE OVERSEAS ACT

Mr. REICHERT. Mr. Speaker, I ask unanimous consent that the Committee on Ways and Means and the Committee on the Budget be dis-

charged from further consideration of the bill (H.R. 3732) to amend section 1113 of the Social Security Act to provide authority for increased fiscal year 2017 and 2018 payments for temporary assistance to United States citizens returned from foreign countries, and ask for its immediate consideration in the House.

The Clerk read the title of the bill.

The SPEAKER pro tempore. Is there objection to the request of the gentleman from Washington?

There was no objection.

The text of the bill is as follows:

H.R. 3732

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled.

SECTION 1. SHORT TITLE.

This Act may be cited as the "Emergency Aid to American Survivors of Hurricanes Irma and Jose Overseas Act".

SEC. 2. INCREASE IN AGGREGATE PAYMENTS FOR FISCAL YEAR 2017 AND 2018 FOR TEMPORARY ASSISTANCE TO UNITED STATES CITIZENS RETURNED FROM FOREIGN COUNTRIES.

(a) IN GENERAL.—Section 1113(d) of the Social Security Act (42 U.S.C. 1313(d)) is amended—

- (1) by striking "fiscal year 2010" and inserting "fiscal years 2017 and 2018"; and
- (2) by striking "that fiscal year" and inserting "each such fiscal year".

(b) EMERGENCY DESIGNATION.—The amounts made available by the amendments made by subsection (a) are designated as an emergency requirement pursuant to section 4(g) of the Statutory Pay-As-You-Go Act of 2010 (2 U.S.C. 933(g)).

The bill was ordered to be engrossed and read a third time, was read the third time, and passed, and a motion to reconsider was laid on the table.

CONTINUATION OF THE NATIONAL EMERGENCY WITH RESPECT TO CERTAIN TERRORIST ATTACKS—MESSAGE FROM THE PRESIDENT OF THE UNITED STATES (H. DOC. NO. 115-67)

The SPEAKER pro tempore laid before the House the following message from the President of the United States; which was read and, together with the accompanying papers, referred to the Committee on Foreign Affairs and ordered to be printed:

To the Congress of the United States:

Section 202(d) of the National Emergencies Act, 50 U.S.C. 1622(d), provides for the automatic termination of a national emergency unless, within 90 days of the anniversary date of its declaration, the President publishes in the *Federal Register* and transmits to the Congress a notice stating that the emergency is to continue in effect beyond the anniversary date. Consistent with this provision, I have sent to the *Federal Register* the enclosed notice, stating that the emergency declared in Proclamation 7463 of September 14, 2001, "National Emergency by Reason of Certain Terrorist Attacks," is to continue in effect beyond September 14, 2017.

The threat of terrorism that resulted in the declaration of a national emergency on September 14, 2001, continues. The authorities that have been invoked under that declaration of a national emergency continue to be critical to the ability of the Armed Forces of the United States to perform essential missions in the United States and around the world to address the continuing threat of terrorism. For these reasons, I have determined that it is necessary to continue in effect the national emergency declared on September 14, 2001, in response to certain terrorist attacks.
