IN RECOGNITION OF MICHAEL B. TRISTER

Ms. MATSUI. Mr. Speaker, I rise today to recognize the life of civil rights attorney Michael B. Trister, who passed away on October 20, 2018. As family, friends and colleagues mourn the loss of a loving family man, a steward of justice, and a voice for the underrepresented, I ask my fellow members of Congress to join me in honoring Mike for his unwavering commitment to defending civil rights and his rich legacy as a lawyer, advocate,

teacher, husband, father and grandfather.

Mike's legal career was marked by profound dedication to serving those in need. His first job out of law school was teaching and developing a legal services program at the University of Mississippi School of Law in the 1960's. There, his work serving the poor and marginalized drew the ire of the state's political hierarchy. When the University terminated its relationship with the program and told Mike he could not both continue to teach and work in the program, he sued in federal court—in Trister v. University of Mississippi—and won the right to do so.

Upon his reinstatement, and as part of his groundbreaking legal practice as the first Executive Director of North Mississippi Rural Legal Services (NMRLS), he focused on advancing the civil and economic rights of African Americans—in the process, contributing greatly to the transformation of poverty law practice in the state. In addition to overseeing school desegregation cases, Mike represented NMRLS lawyers targeted by local law enforcement and defended African American student protesters at the University who were facing both criminal prosecution and calls for expulsion.

In 1970, Mike moved to Washington, D.C., to work at the Children's Defense Fund, eventually serving as Vice President and General Counsel. He later co-founded the firm currently known as Trister, Ross, Schadler & Gold, PLLC. Over thirty years, he worked with a multitude of clients, providing counsel to progressive labor, advocacy, charitable, and political organizations. Mike's practice, at its core, focused on supporting social, economic, and political movements. Beyond his law practice, he also sought to improve the legal profession through teaching and community engagement. Among other things, Mike served as the Chair of the DC Bar Legal Ethics Committee and the DC Bar Rules of Professional Conduct Review Committee. He has been honored for his lifetime of advocacy, and for his many contributions to the profession.

Mr. Speaker, as Mike's wife Nancy Duff Campbell, son Noah Trister, daughter Karen Trister Grace, son-in-law Peter Grace, and grandchildren Jeremy and Mara Grace celebrate his lifetime of achievements and his devotion to his family, I ask all my colleagues to join me in honoring Mike's dedication to advancing civil rights and progressive causes, which began during an era that sorely needed courageous voices.

After earning a graduate degree in history from New York University, Mr. Giovaniello fulfilled an ROTC commitment to the U.S. Army, serving as an officer in Vietnam and Washington, D.C. from 1968 through 1970. After his military service, Mr. Giovaniello worked as a policy analyst and writer for National Journal, a weekly magazine covering the federal government and public policy issues. Later, Mr. Giovaniello began working on Capitol Hill where he served as chief of staff for two members of Congress from California—Rep. Jerry Pettis, R—Calif., 1972 to 1976, and Rep. From 2001 until his retirement this year, Mr. Giovaniello served as the senior vice president of government affairs and chief lobbyist of the National Association of REALTORS, the nation's largest professional association, representing more than one million members involved in all aspects of the residential and commercial real estate industries. Mr. Giovaniello managed the association's government affairs staff of approximately 40 people in Washington, D.C. He also served as NAR's advocate for members of Congress from California, Washington, Nevada, Hawaii and Oregon.

Jerry and I have worked closely together on a number of issues. Perhaps the most consequential was our successful effort to stop large national banks from entering the real estate business. Had the banks prevailed, it would have left home buyers and sellers with fewer choices and higher loan fees. More crucially, it would have made the economic crisis of 2008 even more severe. We all owe Jerry a debt of gratitude for taking on that fight and winning it.

As Staff Director of the Railroads, Pipelines, and Hazardous Materials Subcommittee, she was instrumental in the passage of a number of key bills and has a record of rigorous oversight of the implementation of Congressional mandates. Under her guidance, major authorization bills including the Safe, Accountable, Flexible, Efficient, Transportation Equity Act: A Legacy for Users (SAFETEA-LU), the Pipeline Safety, Regulatory Certainty, and Job Creation Act of 2011, the Fixing America's Surface Transportation (FAST) Act of 2016, the Protecting Our Infrastructure of Pipelines Enhancing Safety (PIPES) Act of 2016 contained important provisions that have demonstrably improved safety and efficiency.

While growing up, Craig developed a deep passion for playing the French horn. He even spent three summers at the Interlochen Center for the Arts in Michigan and intended to spend his life as a musician. Then, while attending Occidental College, he turned his focus and attention to the law. He eventually sold his horn to pay for the first semester of law school at USC. After graduating, he moved from South Pasadena to Riverside, where he became a deputy district attorney. He served there four years, before becoming a public defender.

Craig decided to leap into politics and had his sights set on becoming district attorney. In an effort to bolster his name recognition for a future district attorney campaign, he decided to run for the California Assembly as a Republican. In an unexpected turn of events, Craig wound up winning that race and was elected to serve in the Assembly. Craig would later become the Assembly majority leader from 1969 to 1971. He then resigned to run for the state Senate. Craig won that race and represented the Riverside area in the Senate for

one term. Throughout his legislative career, Craig was an effective advocate for laws requiring the use of breathalyzer tests for suspected drunk drivers and for clean air policies that required cars to undergo smog checks. After leaving office, Craig started a law firm in Sacramento, which he ran before retiring in 1995.

Craig is survived by his wife Patricia Kelley and three children, Eric, Nancy and Lisa Biddle Canez. He had four grandchildren. I want to extend my heartfelt condolences to the Biddle family, his friends, and everyone who had the pleasure of knowing him. Although Craig may be gone, the many life-changing contributions he made in Riverside County and throughout California will have a lasting impact.
