

In July of 2015, lawmakers and the public began to express concerns over the weaponization of drone technology after a college student built a drone capable of firing live ammunition from a mounted .45 caliber semi-automatic handgun. More recently, at least one state legislature has proposed legislation to allow the use of weaponized drones by local and national law enforcement, which is something that concerns me greatly.

This amendment addresses these concerns by explicitly prohibiting the operation of a weaponized drone in the national airspace and by imposing a penalty of up to \$25,000 for each violation.

I am pleased to have worked with Rep. BURGESS on this common-sense, bi-partisan amendment and applaud my colleagues for adopting. I urge all Members to support the underlying bill.

Mary Regula was born in Girard, Ohio on November 29, 1926 to the late Mr. and Mrs. Rogusky. In 1949, Mary graduated from Mount Union College and it is there where she met her future husband Ralph Regula. She was an active member of the community, serving as an educator, historian, and aide in her husband's Congressional office as he represented the 16th Congressional District of Ohio.

In 1994, Mary began laying the foundation for a museum devoted to the first ladies. She told the Washington Post that it wasn't until the 1970s that we decided women had any part in this nation's history. She wanted to help close history's gaping hole by honoring the accomplishments of women. In 1998, former first lady Rosalynn Carter cut the ribbon at the formal opening of the National First Ladies' Library in Canton, Ohio. Mary hoped the museum would serve as a way to document the lives of first ladies and as a resource for scholars and students. The museum was designated a historic site in 2000, expanding to include an education and research center

that has now grown to partner with Ohio schools to provide educational programming about these important figures in American history.

She is dearly missed by her three children Richard Regula (Sherry), David Regula (Jaqueline), and Martha Regula and her four grandchildren, Thomas, Garrett, Olivia and Marissa. She was preceded in death by her parents and her loving husband.

Mary was a wonderful woman, and I am grateful to have had both her and Ralph as friends. She was a valued member of the community and her legacy leaves a lasting impact. I extend my sincerest condolences to all of her family and friends.

FAA REAUTHORIZATION ACT OF

The House in Committee of the Whole House on the state of the Union had under consideration the bill (H.R. 4) to reauthorize programs of the Federal Aviation Administration, and for other purposes:

Ms. JACKSON LEE. Mr. Speaker, I rise to speak in support of the Jackson Lee Amendment to H.R. 4, FAA Reauthorization and Disaster Recovery Reform Act, which was not included in the Rule for this bill.

I am disappointed that the other Jackson Lee Amendments to H.R. 4, the "FAA Reauthorization and Disaster Recovery Reform Act that would have made permanent the FEMA Office of Disaster Response and Recovery, which exists, but has not been codified, was not made in order.

FEMA is the agency that helps people before, during and after disasters.

For 38 years, FEMA's mission remains: to lead America to prepare for, prevent, respond to and recover from disasters with a vision of "A Nation Prepared."

On April 1, 1979, President Jimmy Carter signed the executive order that created the Federal Emergency Management Agency (FEMA).

From day one, FEMA has remained committed to protecting and serving the American people.

That commitment to the people we serve and the belief in our survivor centric mission will never change.

The Federal Emergency Management Agency coordinates the federal government's role in preparing for, preventing, mitigating the effects of, responding to, and recovering from all domestic disasters, whether natural or man-made, including acts of terror.

The Robert T. Stafford Disaster Relief and Emergency Assistance Act (Public Law 100-707), signed into law on November 23, 1988; amended the Disaster Relief Act of 1974 (Public Law 93-288).

The Stafford Act constitutes the statutory authority for most Federal disaster response activities especially as they pertain to the Federal Emergency Management Agency (FEMA) and FEMA programs.

The underlying Disaster Reform language in H.R. 4, the FAA Reauthorization Act provided the opportunity to make strong statement regarding the Federal government's responsibility for disaster response and recovery.

The work of the FEMA Office of Disaster Response and Recovery is critical when disaster strikes and for this reason should be a permanent part of the agency.

This is the office responsible for the Federal wide coordination of disaster response and recovery efforts.

Disaster response also requires that this office work well with non-governmental aid agencies like the Red Cross, and health care
