CONSTITUTIONAL AUTHORITY STATEMENT

Pursuant to clause 7 of rule XII of the Rules of the House of Representatives, the following statements are submitted regarding the specific powers granted to Congress in the Constitution to enact the accompanying bill or joint resolution.

By Mr. ENGEL:

H.R. 5423.

Congress has the power to enact this legislation pursuant to the following:

Article 1, Section 1 of the Constitution.

By Mr. MARSHALL:

Congress has the power to enact this legislation pursuant to the following:

Article IV, Section 3, Clause 2

The constitutional authority of Congress to enact this legislation is provided by Article IV, Section 3, Clause 2 of the United States Constitution, which grants Congress the power to dispose of and make all needful Rules and Regulations respecting the Territory or other Property belonging to the United States.

By Mr. PALLONE:

H.R. 5425.

Congress has the power to enact this legislation pursuant to the following:

Article 1, Section 8, clause 3 of the U.S. Constitution. That provision gives Congress the power "to regulate commerce with foreign nations, and among the several states, and with the Indian tribes.'
