PUBLIC BILLS AND RESOLUTIONS

H.R. 5520. A bill to authorize the Secretary of Veterans Affairs to use the authority of the Secretary to conduct and support research on the efficacy and safety of medicinal cannabis, and for other purposes; to the Committee on Veterans' Affairs.

H.R. 5521. A bill to amend title 38, United States Code, to provide for the non-applicability of non-Department of Veterans Affairs covenants not to compete to the appointment of certain Veterans Health Administration personnel, to permit the Veterans Health Administration to make contingent appointments, and to require certain Veterans Health Administration physicians to complete residency training; to the Committee on Veterans' Affairs.

H.R. 5522. A bill to direct the Secretary of Defense to carry out certain activities to ensure the readiness of the Department of Defense with respect to joint electromagnetic spectrum operations; to the Committee on Armed Services.

A bill to amend title 39, United States Code, to require the United States Postal Service to establish rates for delivery of inbound international mail that do not discriminate between foreign and domestic mailers, to review foreign practices with respect to the exchange of e-commerce goods with the United States, and for other purposes; to the Committee on Oversight and Government Reform, and in addition to the Committees on Ways and Means, and Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 5525. A bill to direct the Secretary of Agriculture to transfer certain National Forest System land in the State of Texas; to the Committee on Agriculture.

By Mrs. HANDEL:

H. Res. 832. A resolution recognizing linemen, the profession of linemen, the contributions of these brave men and women who protect public safety, and expressing support for the designation of April 18, 2018, as National Lineman Appreciation Day; to the Committee on Energy and Commerce.

MEMORIALS

Art. I Sec. 8 cl. 18, under the power "To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof."
