PROVIDING FOR THE USE OF THE CATAFALQUE SITUATED IN THE EXHIBITION HALL OF THE CAPITOL VISITOR CENTER IN CONNECTION WITH MEMORIAL SERVICES TO BE CONDUCTED IN THE ROTUNDA OF THE CAPITOL FOR THE HONORABLE JOHN SIDNEY MCCAIN, III, LATE A SENATOR FROM THE STATE OF ARIZONA

The SPEAKER pro tempore laid before the House a concurrent resolution (S. Con. Res. 43) providing for the use of the catafalque situated in the Exhibition Hall of the Capitol Visitor Center in connection with memorial services to be conducted in the rotunda of the Capitol for the Honorable John Sidney McCain, III, late a Senator from the State of Arizona.

The Clerk read the title of the concurrent resolution.

The text of the concurrent resolution is as follows:

S. CON. RES. 43

Resolved by the Senate (the House of Representatives concurring), That the Architect of the Capitol is authorized and directed to transfer the catafalque which is situated in the Exhibition Hall of the Capitol Visitor Center to the rotunda of the Capitol so that such catafalque may be used in connection with services to be conducted there for the Honorable John Sidney McCain, III, late a Senator from the State of Arizona and formerly a Representative from that State.

The concurrent resolution was concurred in.

AUTHORIZING THE USE OF THE ROTUNDA OF THE CAPITOL FOR THE LYING IN STATE OF THE REMAINS OF THE LATE HONOR-ABLE JOHN SIDNEY McCAIN, III

The SPEAKER pro tempore laid before the House a concurrent resolution (S. Con. Res. 44) authorizing the use of the rotunda of the Capitol for the lying in state of the remains of the late Honorable John Sidney McCain, III.

The Clerk read the title of the concurrent resolution.

The text of the concurrent resolution is as follows:

S. CON. RES. 44

Resolved by the Senate (the House of Representatives concurring), That in recognition of the long and distinguished service rendered to the Nation by John Sidney McCain, III, a Senator from the State of Arizona and formerly a Representative from that State, his remains be permitted to lie in state in the rotunda of the Capitol on August 31 and September 1, 2018, and the Architect of the Capitol, under the direction of the President pro tempore of the Senate and the Speaker of the House of Representatives, shall take all necessary steps for the accomplishment of that purpose.

The concurrent resolution was concurred in.

A motion to reconsider was laid on the table.
