#### PROVIDING FOR A CORRECTION IN THE ENROLLMENT OF S. 2553

The SPEAKER pro tempore. Without objection, the Chair lays before the House the following concurrent resolution (S. Con. Res. 49) providing for a correction in the enrollment of S. 2553.

#### S. CON. RES. 49

*Resolved by the Senate (the House of Representatives concurring).* That in the enrollment of the bill S. 2553, the Secretary of the Senate shall make the following correction:

Amend the title so as to read: "A bill to amend title XVIII of the Social Security Act to prohibit Medicare part D plans from restricting pharmacies from informing individuals regarding the prices for certain drugs and biologicals.".

H.R. 2259. To amend the Peace Corps Act to expand services and benefits for volunteers, and for other purposes.

H.R. 6897. To extend the authorizations of Federal aviation programs, to extend the funding and expenditure authority of the Airport and Airway Trust Fund, and for other purposes.
