Ms. Russo has served on the South Florida Workforce Investment Board, Florida International University's Research Institute for Social and Economic Policy and has worked closely with me as a trusted and valued advisor to my Healthcare Working Group.

The daughter of Lincoln University professors, Monica grew up in rural Pennsylvania and speaks English, Spanish, Portuguese, French and Haitian Kreyol. She graduated magna cum laude from Georgetown University and lives in Miami with her daughter, Giovanna.
