The following components are being conveyed by the proposed sale and are essential to the ability of the SLAM-ER missile to selectively engage hostile targets under a wide range of operations, tactical and environmental conditions

- 2. The highest level of classification of defense articles, components, and services included in this potential sale is CONFIDENTIAL.
- 3. If a technologically advanced adversary were to obtain knowledge of the hardware and software elements, the information could be used to develop countermeasures or equivalent systems, which might reduce system effectiveness or be used in the development of a system with similar or advanced capabilities.

At the request of Mrs. Murray, the name of the Senator from Maryland
