Longstanding Supreme Court precedent recognizes Congress as having plenary power over immigration, giving it almost complete authority to decide whether aliens may enter or remain in the United States.

In exercising its power over immigration, Congress can make laws concerning aliens that would be unconstitutional if applied to citizens. *Demore v. Kirn*, 538 U.S. 510, 522 (2003)

Congress has sole authority to authorize aliens for work—the executive branch does not share such authority with Congress.

To provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrections and repel Invasions;

To provide for organizing, arming, and disciplining, the Militia, and for governing such Part of them as may be employed in the Service of the United States, reserving to the States respectively, the Appointment of the Officers, and the Authority of training the Militia according to the discipline prescribed by Congress;
