RECOGNIZING JACK MANGURTEN'S 100TH BIRTHDAY

Mr. SCHNEIDER. Madam Speaker, I rise today to recognize Jack Mangurten, a beloved member of our community on the occasion of his 100th birthday, which he will celebrate on December 10th. Jack is a Holocaust Survivor, surviving four Nazi extermination camps, and, importantly, is the father of three children, seven grandchildren and sixteen great-grandchildren.

Mr. Mangurten, known affectionately as "Papa Jack" by his family, was born to Baruch and Bashah in Lagov, Poland in 1922. He had five siblings: Sarah, Melvin, Mordechai, Samuel and Barrel Tragically, his father was murdered in 1935 and his mother was forced to move the family to Keltz, where they struggled to make ends meet.

In 1939, the Nazi German regime invaded Poland and World War II broke out in Europe. Over the next six years, Jack would live through the greatest crime against humanity—the Shoah, or Holocaust. Hitler's death machine killed more than 11 million people, including 6 million Jews. Jack's brother Melvin had left Poland for America before the war, but tragically, none of his other relatives survived the Shoah.

Young Jack was transited to four different concentration camps throughout the war: Skarzysko, Bukenwald, Schlieben, and ultimately Terezin, or Theresienstadt. On May 9, 1945, Jack and 30,000 surviving prisoners at Terezin were liberated by the Soviet army.

Soon thereafter, Jack found himself at a displaced person's camp after the war. It was at this camp that he met the love of his life, Lily, to whom he was married for 72 years.

Jack was able to move to the United States thanks to a sponsorship by relatives in Chi-

cago, including his brother Melvin. Despite not knowing English and arriving penniless, he and his wife built a wonderful life and raised a lovely family. Jack worked as a tailor, ultimately opening his own shop on Touhy and Ridge in Chicago where he worked for 40 years.

Jack is an active member of Congregation Beth Shalom in Northbrook. As a Kohan, he is honored to be called to the Torah for the first blessing every Rosh Hashanah.

To this day, Jack enjoys keeping up with current events, especially news out of Israel, and spending time with his three children and their spouses (Barbara and Michael Zaransky, Shel and Nancy Mangurten, Irv and Linda Mangurten), grandchildren (Brad married to Jamie, Karen married to Michael, Erin married to Vince, Gayle married to Matt, Lindsay married to Eric, Lisa married to Daniel, and Lauren married to Corey) and great-grandchildren (Livia, Sidney, Maggie, Jude, Eli, Theo, Estee, Bernie, Simon, Owen, Leah, Cameron, Colby, Chance, Lily and Saide).

The Tenth District of Illinois, and the entire Nation are proud to wish Jack a Happy 100th Birthday. And it is my great honor and privilege to celebrate his life and his family, and to recognize his amazing life story.

Chef Olea first graced Santa Fe with his culinary talents back in 1991. Donning his signature cowboy hat, he infuses his Mexican dishes-particularly his New Mexican molesat his current restaurant, Sazón, with fresh and local ingredients. He created a New Mexican mole in 2009 in celebration of the 400year anniversary of the founding of Santa Fe. The recent James Beard recognition is just the latest accolade in his career. He also earned the National Restaurant Association's Faces of Diversity Award and was recognized by former First Lady, Michelle Obama, for his involvement in Cooking with Kids. He even served as President of the Santa Fe Wine and Chile Fiesta a few years back.

Recent recognitions have been 2019 Restaurateur of the Year by the New Mexico Restaurant Association; past three years named in Trip Advisor's Top 10 Best Fine Dining Restaurants in the U.S.; and the AAA 4 Diamond Award to Sazón. He is also quick to say these awards are not for him; they are his gifts to Santa Fe, as he works toward changing the

Chef Olea's eyes light up the most, though, when he speaks about his experiences beyond his renowned cuisine. Along with the New Mexico Restaurant Association, he helps students obtain scholarships. Through Cooking with Kids, he teaches families to make fun and nutritious meals. He also emphasizes his work with the Children's Cancer Foundation. Simply put, he strives to improve the quality of life for his entire community.

If you ask Chef Olea what he is most proud of, he'll reply that it is how Santa Fe and New Mexico have adopted him. If you ask me, we are the ones who are so lucky he has chosen to make our community home.

Mr. Canning is a native of Beacon Falls, Connecticut and a graduate of Stonehill College in Easton, Massachusetts. After receiving a Bachelor of Arts in Criminal Justice and Sociology, he joined Nestlé Waters as a Sales Manager before being promoted to International Customer Development Director.

In 2006, Mr. Canning moved from Paris to Calistoga when Nestlé appointed him Director of Calistoga Mineral Water. Following nearly four years in this position, Mr. Canning left Nestlé to begin a career in public service. In 2010, Mr. Canning became the Executive Director for the Calistoga Chamber of Commerce and Visitor Center. Soon after, he was elected to the City Council and in 2012 was elected as Mayor. During his tenure, Mr. Canning led Calistoga through a recession, the COVID–19 pandemic, four wildfires and multiple evacuations. His decade as mayor is the longest since at least the 1960's.

As Mayor, Mr. Canning brought countless infrastructure improvements to Calistoga including major repairs to the sewer system and sidewalks. He helped create a pedestrian bridge to Pioneer Park, invested in children's programs, developed local parks and enhanced social services. Because of his hard work and determination, county agency representatives are now located in Calistoga to better support children and seniors. Mr. Canning has also led efforts to increase affordable housing, acquire a fairgrounds and reduce the city's impact on the environment.

Madam Speaker, we thank Mayor Canning for his selfless service and commitment to the people of Calistoga. His efforts have made Calistoga a more welcoming, supportive, green and beautiful city. Therefore, it is fitting and proper that we honor him here today.
