He also served as Chair of the Select Committee on Coastal Protection and Access to Natural Resources and is a member of the Banking and Finance Committee.

During the disastrous CZU complex fires of 2020, Mark was an ardent and effective advocate for allocation of state resources for residents and businesses affected by the disaster.
