Mr. DIAZ-BALART. Madam Speaker, I rise today to acknowledge Yordenis Ugás Hernández for his exceptional athletic accomplishments, fierce patriotism, and dedication to the cause of freedom for the Cuban people.

Mr. Ugás said on August 12, 2021, “I’m a fighter not only inside of the ring, but outside of the ring; I fight for the freedom of my people. That’s the most important thing to me. I hope that all those who fight for freedom in Cuba are safe and know that I will fight for them on Saturday, August 21.” He also stated that, “I’m dedicating this fight to all my fellow Cubans fighting for freedom every day. I want to make history for my legacy and for all the Cubans around the world. This will be huge for the entire Latin community.” Mr. Ugás reportedly listened to the pro-freedom Cuban song “Patria y Vida” (“Homeland and Life”) when heading into the ring for the fight, and went on to win that boxing match against long-time champion, Manny Pacquiao. After his historic win, he exclaimed, “Homeland and Life, Homeland and Life, not Homeland or Death,” which is a phrase that has become a mantra for Cuba’s pro-democracy movement.

Mr. Ugás is not just a fighter in the ring; he is a freedom fighter. He survived being sent to a Cuban prison, which was a punishment he endured simply for attempting to escape oppression. He ultimately was able to enter the United States in 2010. Since then, not only has Mr. Ugás thrived in his field, but he has become an inspiration to people seeking freedom all over the world.

Madam Speaker, I admire this talented and spirited athlete who left Cuba, but has never left the Cuban people. He has repeatedly expressed his solidarity with those brave leaders and activists on the island who are risking everything for liberty. Mr. Ugás has inspired a new generation of Cubans both in Cuba and in exile, and I commend him for his fierce dedication and potency—both inside and outside the ring.

If it were not for advocates like her, there would be far fewer solutions available to those affected by this crisis. REMEMBERING LAWRENCE
BROOKS, 112-YEAR-OLD WWII
VETERAN

Mr. CARTER of Louisiana. Madam Speaker, today I remember Lawrence Brooks of New Orleans, the United States’ oldest living World War II veteran, who was laid down in his eternal resting place on Saturday, January 15, 2022 at the age of 112.

Mr. Brooks was born in 1909 in Norwood, Louisiana and grew up outside of Stephenson, Mississippi. As part of a large family, his parents were sharecroppers, and then worked at a sawmill during the Great Depression.

He was drafted into the Army at 21 in 1940 and was a participant in the famed Louisiana Maneuvers, where hundreds of thousands of soldiers conducted readiness exercises at home to prepare a response to Germany's invasion of Poland and France.

After his required one-year service, Brooks was originally discharged and returned to New Orleans. However, after the attack on Pearl Harbor he re-enlisted. As he himself put it, after Pearl Harbor, "There was no question" that he would continue his service.

He joined the 91st Engineer Battalion, a unit comprised of 1,193 Black enlisted soldiers and 25 white officers. Soon, the unit boarded a converted ocean liner in New York and headed to the South Pacific.

After an extended voyage due to dodging submarines, the 91st arrived in Queensland, Australia, an Allied Forces defensive base in the war against Japan.

Private First-Class Brooks fondly remembers the Australian people's acceptance of the Black soldiers and the equal treatment they experienced without the specter of segregation.

Without Jim Crow, Brooks made white friends, and attended dance halls, cinemas and hotels freely—freedoms he had never experienced before.

Brooks did not see combat during this deployment, instead serving as a staff member to officers, lieutenants, and captains.

While the white officers ate and lived separately from the Black soldiers, the private said he never experienced discrimination or racism during his service.

Their battalion was also tasked with building several buildings, hospitals, roads, housing, and recreation centers throughout Horn Island, Papua-New Guinea and the Philippines, dodging Japanese bomb raids.

Brooks' unit left the South Pacific in 1944 and he left the service a year later. Many of his stories focus on the positive—a sign of his outlook on life.

He received the Good Conduct Medal, Meritorious Service Medal, and Presidential Unit Medal. He wanted to attend college, but he never received his GI benefits—an injustice tragically felt by many Black veterans of the Second World War. His daughter Vanessa Brooks says that he was also never offered a low-interest bank loan or a reduced down payment for a house.

Asked in late 2021 what he would like his legacy to be, he said, "I would like to be remembered as a strong man. A good soldier." He certainly will be.

Mr. Brooks was a local celebrity, and in 2021 for his 112th birthday he was honored with a drive-through party. He danced on his porch during a serenade serenaded by the World War II museum's musical trio, the Victory Belles.

A military flyover flew above his Central City home in New Orleans.

He loved the New Orleans Saints and spent this past holiday season cheering them on with family.

Mr. Brooks lost his original Army uniform during Hurricane Katrina, but was presented with an authentic reproduction and his old unit's badge last November.

His family says they plan to bury Mr. Brooks in his replicate uniform, as was his request.

My thoughts are with the Brooks family as they say goodbye to their beloved patriarch.

I pray that Mr. Lawrence Brooks is at peace after his 112 years of life. We are all indebted to his service and should be inspired by this "good soldier's" positivity and zest for life. I know I am.

Founded in 2008, My Possibilities served as the first full-day, full-year continuing educational program for adults with developmental disabilities in Collin County. Under her steadfast leadership, the organization has worked with over 600 HIPster's—Hugely Important People—equipping them with the tools needed to develop employable skills and live full and independent lives. The college-style campus offers students educational, socialization, and residential opportunities as well as job placement programs in the community.

Throughout Charmaine's tenure, she could regularly be found roaming the halls of the campus, interacting with students, and giving them high-fives and hugs. As a testament to her many efforts and in honor of her dedication, in 2019 the Plano Independent School District named their Adult Transition Center after Charmaine.

In addition to her service with My Possibilities, Mrs. Solomon is a Licensed Professional Counselor, devoted wife, and loving mother of four. She has been an active member of CASA of Collin County for more than eight years and has also volunteered her time working with at-risk youth at CITY House.

Madam Speaker, as Charmaine Solomon begins a new chapter of her life following her final meeting as the longtime Chairman of My Possibilities, I ask my colleagues in the House of Representatives to join me today in honoring her incredible impact in North Texas and the Third Congressional District.

Mr. PERLMUTTER. Madam Speaker, I rise today to recognize and applaud Westminster Fire Chief Doug Hall for his 43 years of service to the City of Westminster and surrounding communities.

For four decades, Chief Hall has been active within the Westminster community and fire department. Chief Hall began his career in 1978 when the City had 18 firefighters, an administrative assistant, and only one of its three fire stations was staffed. The Westminster Fire Department now has 143 employees, with 123 serving in an emergency response capacity from six staffed fire stations.

For the past 10 years, Chief Hall has served as Fire Chief. Under his leadership, Westminster Fire Department earned an ISO Class 1 rating, the Center for Public Safety Excellence's (CPSE) highest accreditation. Less than 300 agencies have received an ISO Class 1 accreditation nationally. In addition to overseeing the modernization of the department, including upgrading public safety telecommunications systems and other technological upgrades, Chief Hall developed new career pathways for future firefighters through a multi-agency firefighter academy and officer development program.

Outside of the Westminster community, Chief Hall is recognized as a leader in the Colorado firefighting community. He served as President of the Board of Directors for the Adams and Jefferson County Hazardous Materials Response Authority from 2019 to 2021 and represents Colorado municipalities as a member of the Colorado Fire Commission. Chief Hall has been a member of the Westminster Rotary Club for 13 years.

I extend my deepest appreciation for Chief Hall and his service and dedication to our community. I thank him for his continuous dedication to serving the people of Colorado.
