50TH ANNIVERSARY OF FIESTA DEL SOL

Mr. GARCÍA of Illinois. Madam Speaker, I want to honor Fiesta Del Sol, the largest Latino festival in the Midwest, as it celebrates its 50th Anniversary this month.

Fiesta Del Sol hails from my district in Pilsen—the first neighborhood my parents and siblings found a home in when we arrived from Mexico. Pilsen's been a gateway for countless immigrant families, and it proudly continues to reflect and elevate the Mexican community in Chicago. We gather during the Fiesta del Sol to celebrate the richness of our culture through music, food, and community empowerment.

Born in 1973, Fiesta del Sol was in part the result of the rising political power of the Chicano and Mexican American community. That year, the Pilsen Neighborhood Community Council, a non-profit community-based organization, led a successful campaign to build a new public high school in the heart of the neighborhood, the Benito Juárez Community Academy. The organizers hosted a block party to celebrate this victory, and thus the first Fiesta del Sol was born.

Today, this four-day event attracts more than one million people, spans an eightblock space down Cermak Road, and can be seen from miles around in Chicago because of its Ferris wheel and bright lights. Fiesta del Sol also raises funds to provide scholarships for young people needing assistance as they enter colleges and universities.

In its more than 100 booths you will find some of the best Mexican food in town, as well as artists and artisans who come to showcase their talent. Fiesta also is an opportunity for the community to get information about health care, immigration, environmental justice and college readiness. And while it features popular talent, it has also created opportunities for up-and-coming performers.

Fiesta del Sol has become such a significant event for the Latino community, that a promotional poster for the festival, created by artist Alejandro Romero, is now part of the Smithsonian American Art collection.

As the Mexican community in Chicago has grown and evolved, so has Fiesta del Sol. Organizations like the Pilsen Neighborhood Community Council have expanded their reach, continuing to engage and activate people to address the community needs, training organizers, and neighbors to advocate for themselves, their families and for the benefit of the community as a whole.

Fiesta del Sol reminds us of the rich history of the Mexican community and the remarkable cultural and economic contributions we have brought to Chicago and the Midwest. Let's celebrate its 50th anniversary.

RECOGNIZING THE 125TH ANNIVER-SARY OF THE HAMLINE CHURCH DINING HALL

Ms. McCOLLUM. Madam Speaker, I rise today to honor the congregation of Hamline Church on the momentous occasion of the 125th anniversary of the Hamline Church Dining Hall at the Minnesota State Fair. The dining hall is the oldest continuous food concession at what we like to call "The Great Minnesota Get-Together."

Back in 1897, a small group of women from the Hamline Methodist Episcopal Church Ladies Aid Society decided to try selling cold drinks and sandwiches at the fair to raise money for the church. This humble fundraising effort quickly grew into a dining hall with a full menu that is a staple of the Minnesota State Fair. Unlike those early days, the Hamline Church Dining Hall at 1667 Dan Patch Avenue is now owned by the church and boasts modem conveniences of plumbing and electricity, which are appreciated by patrons and volunteers alike.

Over the' years, there have been a few other changes. In 1935, for a dinner of meat or ham loaf, boiled potatoes, coleslaw, beet pickles; pie, ice cream and a beverage, plus free second helpings, a patron at the Hamline Dining Hall paid only 35 cents. This value and the homegrown hospitality helped the hall survive the Great Depression when many others closed down. World War II food rationing forced more flexibility and adaptation. As the

menu has grown and changed over the many years, a perennial favorite is ham loaf topped with honey-mustard sauce. In 2012 they partnered with local small business Izzy's Ice Cream and began selling ice cream and other take-away items, including their very own flavor of Church Elderberry Ice Cream. An adaptation of their traditional Swedish meatballs to Cranberry Wild Rice Meatballs served with lingonberry sauce earned them a spot on the highly acclaimed New Foods list for the fair in 2017.

With more than 300 food vendors at the Minnesota State Fair, the Hamline Church Dining Hall remains popular for its high-quality food and generous hospitality. During each of the past 125 years, the Dining Hall has been largely volunteer-run, 25 of whom have been specially recognized by the fair for 50 years of service. Their hospitality extends well beyond fairgoers—a portion of each year's proceeds goes to provide meals for organizations like The Sheridan Story, Emma Norton Services and Feed My Starving Children.

Madam Speaker, please join me in paying tribute to the congregation and many incredible volunteers of the Hamline Church Dining Hall as they celebrate 125 years of serving up delicious homecooked meals and generous hospitality to hungry Minnesota State Fairgoers.

Ms. PINGREE. Madam Speaker, today, I rise to recognize a courageous veteran, a resilient leader, and a selfless Mainer. Command Sergeant Major Gretchen Evans of Brunswick, Maine is one of the most decorated female veterans in American history serving in the United States Army for 27 years. Since enlisting at age 19, CSM Evans has served in tours of Kosovo, Bosnia, Somalia, Iraq, and Afghanistan, where she was responsible for more than 30,000 ground troops. Ms. Evans' honorable dedication to defending our country earned her the position of Command Sergeant Major, the highest non-commissioned officer rank in the military.

In 2006, Command Sergeant Major Evans survived a barrage of mortar fire in Afghanistan which rendered her deaf and wounded. After her combat injury, she quickly found renewed vitality by learning to lip read, forging relationships with her "hearing dogs," Aura and Rusty, and by proactively reaching out to fellow veterans with similar lived experience.

Today, in Maine, CSM Evans continues to give back as an active fundraiser and ambassador for local nonprofits which provide support services to disabled veterans and which seek to prevent veteran experienced social isolation and depression. Additionally, CSM Evans is a distinguished public speaker who advocates for the importance of leadership, perseverance, and teamwork, as a part of "Women Veterans Speak," a national speaker's bureau.

When she is not inspiring others to serve, CSM Evans pursues her passion for extreme sports, running 40 marathons. CSM Evans also led UNBROKEN, the first all-mixed abilities team to complete in "The World's Toughest Race," a 670-kilometer, week-long endurance race held in Fiji. This achievement recently earned her the Pat Tillman Award for Service at the 2022 ESPYs, which honors individuals with both strong connections to sports and community leadership. This fall, CSM Evans will also be inducted into the U.S. Veteran's Hall of Fame in recognition for her outstanding meritorious service to our country.

I thank Command Sergeant Major Gretchen Evans, for her selfless acts of duty to keep this Nation safe. The people of Maine are incredibly lucky to have her as an advocate, a leader, and a community member. I wish her the very best and I look forward to seeing her continue to thrive.
