and recent recipient of France's highest distinction, the Ordre national de la legion d'honneur, also known as the Legion of Honor.

On July 14, 2022, Mr. Marvel was presented the Legion of Honor by the French Ambassador to the United States, Phillipe Etienne. The Legion of Honor was first created over two centuries ago to reward eminent military and civil merits in service or defense of France. Created as an order of merit, foreign citizens may be awarded this recognition for their actions in support of France. For a World War Two Veteran like Mr. Marvel to be awarded the Legion of Honor, they must prove they were involved in combat operations within France.

As a Private First Class with the 45th Infantry Division of the United States Army, Mr. Marvel's service demonstrated exceptional bravery, character, and valor. Arriving in France shortly after the Battle of the Bulge, Mr. Marvel was soon given a vital mission to clear mines and booby traps. That mission brought Mr. Marvel and another soldier into direct contact with enemy troops. For his successful actions that day, Mr. Marvel was awarded the Bronze Star. After this action, Mr. Marvel participated in several dangerous combat missions to help liberate France from Nazi Germany, including missions as a bazookaman and in notable amphibious operations across the Rhine River.

Despite the significant combat Mr. Marvel and his unit saw in Europe, perhaps the most harrowing experience was their actions to liberate the victims in the Dachau Concentration Camp. As Mr. Marvel and the 45th Infantry Division moved toward Dachau, they were engaged in fierce combat with German troops still defending the camp. Mr. Marvel would help liberate 32,000 captives of Dachau. But, as Mr. Marvel recalls, the "sights in this camp I will never ever forget."

Mr. Marvel was awarded numerous awards for his service, including the Bronze Star, the Combat Infantry Badge, and several campaign medals. With the latest award of the Legion of Honor, Mr. Marvel joins a distinguished group of Americans, including President Dwight D. Eisenhower, Audie Murphy, Chuck Yeager, and many others.

On behalf of the State of Delaware and a grateful nation, I thank Mr. Marvel for his service to our country. He sacrificed greatly to safeguard freedom and democracy. He is a testament to our Nation and his actions were in keeping with the highest traditions of the United States Army. Congratulations once again to Mr. Marvel on this honor, as he brings great pride to Delaware and the United States.

I support passage of this crucially important legislation which accelerates the production of U.S.-made semiconductors by providing support along the entire supply chain.

HONORING SAM MILLS

Mr. PALLONE. Madam Speaker, I rise today in commemoration of the life of Sam Mills as he is posthumously enshrined into the Pro Football Hall of Fame on August 6, 2022.

Despite often being overlooked due to his small stature as a linebacker, Sam Mills persisted and shattered misperceptions and records throughout his career. He never gave up on or off the field, fighting until the end of his two-year battle with cancer, which tragically took him too soon at the age of 45. Re-

fusing to let his diagnosis stop him, Mr. Mills' motto to "Keep Pounding" became a rallying cry for his team and future generations of players.

Born in Neptune and raised in Long Branch, Mr. Mills was a New Jersey native who always stayed true to his roots. A standout player for Long Branch High School, Mr. Mills was a first-team All-Shore selection in his senior year. His Long Branch jersey is proudly displayed in the high school gymnasium alongside his Carolina Panthers jersey. Each year, two players in the Shore Sports Network All-Shore Gridiron Classic are chosen to receive the Sam Mills Award in his honor.

A walk-on at Montclair State, Mr. Mills left his mark on the university as he did in Long Branch. He set records, was recognized for his performance, and led the team as captain for two seasons. The university retired his jersey number and memorialized his legacy with a residence hall and the dining area, Sam's Place, named after him. In addition to his achievements on the field, Sam Mills graduated Montclair State with a Bachelor of Science degree and was later awarded an honorary doctoral degree from the university. He has been inducted into the Montclair State University Hall of Fame as well as the College Football Hall of Fame.

Overcoming rejections by other leagues, Sam Mills played three seasons in the United States Football League (USFL), where his talent did not go unnoticed. When his USFL Philadelphia/Baltimore Stars coach Jim Mora was named head coach of the New Orleans Saints, he took Mr. Mills with him. Mr. Mills' athletic prowess and leadership helped the Saints to four playoff appearances in his 9 seasons with the team. He was then a key player with the 1995 expansion team Carolina Panthers, where he played until his retirement in 1997. At the end of his NFL playing career. Sam Mills recorded 12 seasons and 181 games, 5 Pro Bowl appearances, 3 All-Pro and All-NFC selections, and remarkable career statistics.

After retiring as a player, Mr. Mills found his way back to the field in 1999, working as an assistant coach for the Carolina Panthers. Having nearly entered the teaching profession before joining the USFL, Mr. Mills was a natural as a coach. He continued to coach throughout his cancer treatments, inspiring the franchise to this day. "Keep Pounding" is inscribed in the collar of each team jersey, the Keep Pounding Drum is played before each home game, and a statue depicting Mr. Mills was erected outside their stadium. Likewise, both his Panthers and Saints jerseys are retired.

Mr. Mills is remembered by his loving family, who will be in Canton, Ohio for the Pro Football Hall of Fame celebration, as well as former teammates, players, and coaches. His induction into the Pro Football Hall of Fame ensures that future players and individuals alike will be inspired by his story. His character and tenacity are as much a part of his legacy as his statistics and accomplishments, and his impact on those he has mentored directly, and indirectly, is indelible.

Madam Speaker, I sincerely hope that my colleagues will join me in honoring the life and accomplishments of Sam Mills. His election to the Pro Football Hall of Fame Class of 2022 is well-earned and truly deserving of this body's recognition. Keep Pounding.

Representative Daley taught and led the borough for seven years before being elected to the Pennsylvania House of Representatives in 1982.

Representative Daley's legislative achievements included enabling farms to co-exist with residential areas and reforming mortgages during the 2008 financial crash.
