In 1982, the Perkins family returned to California and lived in the city of Pasadena where Perkins and his wife founded Harambee Ministries in Northwest Pasadena, a neighborhood that had one of the highest daytime crime rates in California. Harambee Ministries is yet standing, running numerous programs including after-school tutoring, Good News Bible Clubs, an award-winning technology center, summer day camp, youth internship programs, and a college scholarship program called Harambee Preparatory School (HPS).

In 1989, John Perkins called together a group of Christian leaders from across America that was bonded by one significant commitment—expressing the love of Christ in America's poor communities, not at arm's length, but at the grass-roots level. An association was formed and the Christian Community Development Association (CCDA) held its first annual national conference in Chicago in 1989. CCDA has grown frm 37 founding members to 3,500 annual national conference attendees.

Despite being a third grade drop-out, Perkins has been recognized for his work with seventeen (17) honorary doctorates from colleges and universities across the country. Wheaton College bestowed his first Honorary Doctor of Law in 1980; Taylor University in 2015; Millsaps College in 2018; and Wesley Biblical Seminary being the most recent in 2022.

In 2005, Seattle Pacific University established. The John Perkins Center for Reconciliation & Justice. Since then, Dr. Perkins has been honored with Perkins Endowed Fellowships, Perkins Endowed Scholarships, Perkins Houses, Perkins Dorm Floor, and/or John M. Perkins Chair at: Calvin University, Northern Seminary, Wheaton College, University of Virginia, New Orleans Baptist Seminary, Indiana Wesley Seminary, Jackson State University, Wake Forest Divinity, and Moody Bible Institute

Dr. Perkins is an international speaker and teacher on reconciliation, leadership, and the philosophy of ministry known as Christian Community Development (CCD). he has served under five (5) United States Presidents. He is proud to have honorably served his country in the Korean War.

Dr. Perkins is a best-selling author who has authored 17 books including his classic autobiography Let Justice Roll Down (Baker Books, 20212, revised update), With Justice For All (Baker Books, 2011, revised update). Leadership Revolution: Developing the Vision & Practice of Freedom & Justice (Baker Books, 2012), A Quiet Revolution (Marshalls, 1985, revised update), Making Neighborhoods Whole: a Handbook for Christian Community Development (IVP Books, 2013), and Do All Lives Matter (Baker Books, 2017), Dream With Me (Baker Books, 2017). His 3-part manifesto, One Blood (Moody Publications, 2018) is an Amazon #1 Best Seller-Christian Leadership; He Calls Me Friend (Moody Publications, 2019); and most recent release is Count It All Joy (Moody Publications, 2021).

Outraged by the disenfranchisement of farmworker families like his own, Henry became the youngest deputy registrar in the state of California. He registered countless farm workers to vote and make their voices heard.

After graduating from the University of Oregon, where Henry was one of the very few Mexican-Americans on campus, he worked for the State of California's Department of Industrial Relations for 31 years. His work was so impactful to so many—often acting as a one-person investigation team for the Labor Commission. Thinking of his own family's experience, Henry felt a deep sense of fulfillment helping farm workers receive wages they were unfairly denied.

While working in San Francisco, Henry quickly ascended to Senior Deputy Labor Commissioner, investigating the workplace conditions of sweat shops, agricultural companies, car washes and construction sites. Henry always understood the importance of empowering workers, which led him to lead the charge in unionizing carwash workers in LA.

Henry and his wife, Martha, eventually settled down in Whittier, California, but Henry's passion for political change and empowering working families never faded.

In his final months of life, Henry continued to register voters, and volunteer countless hours to get out the vote. As a result of his tireless activism, Henry was honored by the Los Angeles County Democratic Party as "Democrat of the Year."

Henry was such a great activist not just because of the time he spent on work, but also the time he invested in mentorship, friendship, and guidance to local leaders. I am proud to have called Henry a friend and a role model.

Henry Huerta left us too soon. His absence is greatly felt by my community, but his legacy as a voice for the disenfranchised will be remembered for generations. I join Henry's wife, Martha, his 2 children, Enrique Jr., and Zenaida, and all his family and friends in celebrating the difference he made in our community through a full and meaningful life.

Willie B. Owens, Sr. was born on November 8, 1938, in Branchville, South Carolina to the late Bennie C. Owens and Lillie Ruth Warren Owens. Willie B., as he was always affectionately known, graduated from Wilkinson High School in 1956. He earned a Bachelor of Science Degree in Agriculture in 1960 and a Master of Education Degree in 1966 from South Carolina State College. He went on to earn his E.D. from the Citadel and did further study at Clemson University and the University of South Carolina.

I knew Willie B. from our days together on the campus of South Carolina State where we both were active as students in campus activities and civil rights protests in Orangeburg County. He continued his activism throughout his life participating in voter registration drives and taking people to the polls to vote. He was also a Life Member of the NAACP, and always stood up against injustices.

Willie B. spent his professional career working in education. He began in the public schools serving as an agriculture teacher at Richard Carroll High School and Bamberg-Ehrhardt High School. He served as Bamberg-Ehrhardt High School's Director of Transportation and then Principal. He also had a stint as Director of the Future Farmers of America Camp in Orangeburg, and as Director of Vocational Programs for Bamberg School District
