RESOLUTION OF SUPPORT FOR UKRAINE

The Board of Directors of the International Foundation for Electoral Systems (IFES), meeting in Arlington, Virginia, USA on this 15th day of March 2022, does hereby declare its full support for the people of Ukraine, and the sovereignty, independence and territorial integrity of Ukraine.

The Board of Directors condemns the invasion of Ukraine by the Russian Federation as a flagrant act of aggression and violation of international law, including the Helsinki Final Act and the United Nations Charter.

Since Ukraine became an independent country more than 30 years ago, its people have repeatedly chosen the path of freedom and democracy. Over the course of three decades, IFES has been honored to support Ukrainians in their efforts to strengthen and safeguard their democracy. The Board of Directors of IFES affirms its continued solidarity with the Ukrainian people, who are bravely resisting this unprovoked assault on their freedom and democracy.

The Board of Directors pays tribute to the contributions of current and former IFES staff in Ukraine who have helped to build Ukrainian democracy. We stand in solidarity with these IFES staff, with the Central Election Commission of Ukraine, and with our civil society partners and the members of the public institutions with whom we work. The Board of Directors further recognizes the important work of those fighting for democracy and human rights in and around Russia and Belarus, especially those who have worked to oppose the invasion of Ukraine.

REMEMBERING THE LIFE OF DR. RICHARD RUSSELL

Mr. KELLY of Mississippi. Madam Speaker, I rise today to honor the life of Dr. Richard Russell. Dr. Richard H. Russell died on August 28, 2022. He was born on May 3, 1942 in his family home in the Hurricane Community in Pontotoc County. He was the youngest child born to Robert Kendall Russell and Ida Warren Russell, who were 63 and 42 respectively on the date of his birth. He had nine siblings whom he knew and two who died before his birth. He survived all of them. He leaves his wife, Jackie Bass Russell, three children, Regan Russell (Mary Jennifer); Sandy Sullivan

(Vic) and Melissa Russell, and four grandchildren, Sylvie Russell, Will Sullivan, George Sullivan and Paige Carruth.

Dr. Russell graduated valedictorian from the Hurricane school system in 1960, top of his class at the University of Mississippi School of Pharmacy in 1965, and in 1971 from the University of Mississippi Medical School in Jackson, where he simultaneously worked as a part-time pharmacist and taught pharmacology to nursing students at St. Dominic Hospital. He served a one-year internship in Savannah, Georgia, where a staff physician called the Mississippi doctors (including Dr. Sam Creekmore) the best interns they had ever had, before choosing New Albany as his forever home. He never thereafter doubted that he had made a wise choice.

At the Union County Hospital, later Baptist Memorial-Union County, he proudly delivered approximately 2,000 babies, co-ran the emergency room night and day for seven years, served as New Albany's first I.C.U. Director, served three terms as Chief of Staff, and played an instrumental role in convincing Baptist to take over the Union County Hospital. He was very proud that the New Albany Medical Community grew from five doctors the day before he and Dr. Creekmore arrived to a thriving local medical community with a hospital recently voted the Best Small Hospital in the State of Mississippi. He also served his community in various ways, including as the Union County Republican Chairman and on the New Albany School Board.

Richard was born into a rich community where he was surrounded by family and friends, and he carried a love of community all through his life. During his thirty-nine years of practice as a Family Practice Physician in New Albany, Verona and at the University of Mississippi, he rarely passed a day without meeting someone he called a cousin, and he never went a day without meeting someone he called friend. He was loved by many of his patients because of his fondness for them, his familiarity with their families and family histories, and his gentle and friendly spirit. A pharmaceutical salesman once added that you could always count of Dr. Russell to tell you "one good joke—and two bad ones".

In his later years Dr. Russell often reflected upon how lucky he had been to know so many people, to serve them and their families, particularly in their times of deepest need, many times to sit with them in their last moments, and to enjoy his patients' frequent expressions of appreciation and affection for him. Madam Speaker, Dr. Russell will be missed.

As the Morton High School athletics department has grown, so has the prominence of their girls' basketball team, known as the

"Lady Potter's". In an unprecedented record of success in eight seasons from 2015 to 2022, the Lady Potters won four Illinois State Championships, three in succession. In that time, they have won 244 games and only lost 23. The Lady Potter's have been led to victory 559 times against 159 defeats by the architect, builder, and coach of the team, Bob Becker. Becker has been awarded Coach of the Year multiple times by the Illinois High School Association and was named to the Illinois basketball coaches' Hall of Fame in 2020. In addition, seven of his Lady Potters have gone on to play Division I college basketball.

A kind, retired Hall of Fame sportswriter brought their story to the nation, comparing them to the current NBA champions: "They are the Golden State Warriors, only with Pony Tails". Their accomplishments also garnered public praise in a CBS' 60 Minutes feature.

With 2022 marking the 50th anniversary of Title IX, which guaranteed the Lady Potter's right to play, there is much to celebrate. The Class of '72 also celebrates their 50th anniversary as graduates of Morton High School this year. Morton High School continues to honor the legacy of the classes before them and their tremendous achievements throughout the year.

Congratulations to classes past and present of Morton High School, including the 2022 Lady Potter's basketball team. The school pride is worthy of celebration. Keep up the good work.

HONORING THE MEMORY OF JOSEPH MCCOY AND BENJAMIN THOMAS

Mr. BEYER. Madam Speaker, I rise in memory of Joseph McCoy and Benjamin Thomas—and to commend the City of Alexandria for its work on the Alexandria Community Remembrance Project (ACRP).

Through its partnership with the Equal Justice Initiative, the ACRP has brought our community together to remember the city's history of racial terror and to memorialize Joseph McCoy and Benjamin Thomas, who were lynched in 1897 and 1899, respectively. These lynchings were two of 86 documented lynchings committed in Virginia between 1880 and 1930. These acts of premeditated violence were deliberate attempts by whites to terrorize and control black populations across the state.

As our community convenes again on September 24, 2022 we do so to collect soil representing these two young men's lives. In October, Alexandrians will then make a pilgrimage to Montgomery, Alabama to deliver this sacred soil to its final resting place at the National Memorial for Peace and Justice.

These events also occur during a year in which the Emmitt Till Antilynching Act, a federal bill making lynching a federal hate crime, was signed into law by President Biden on March 29. I was proud to support this long overdue legislation in the U.S. House of Rep-

resentatives, but also recognize that we still have much more work to do.

It is incumbent on all of us to remember this shameful episode of our history and others like it. In doing so, we are better able to see the continuous chain of racially motivated violence against Black Americans that spans our nation's history. We can truly honor the memories of Joseph McCoy and Benjamin Thomas, along with the countless number of named and unnamed victims of racial violence, by seeking justice for all Americans and working to build a more inclusive society.

Phoua was born in 1952 in Sa Luong, Laos. She grounded her life in service to community, sharing cultural wisdom with younger generations of Hmong Minnesotans who did not get to experience the same life she did—being carried on her father's back from village to village, planting rice seedlings, and gathering water for her family before the sun rose.

Phoua's family noted that over the course of her life, she worked as "an assembly operator, a waitress, a certified seamstress, a wreathmaker, and a farmer." Phoua became a distinguished member of the Twin Cities' Hmong community and contributed to countless efforts to build political, social, and economic capital. She was known as a mainstay of the St. Paul Farmers Market, where she sold her family's fruits and vegetables for two decades. She was a founding member of the Hmong American Farmers Association where she "led the charge to lease a 155-acre farm, helped launch a marketing cooperative and food hub, spearheaded a micro-lending program, and tested key modules in a national training program," as remarked by Minnesota Governor Tim Walz

Phoua instilled in her children and grand-children that sense of service, and our community will continue to be blessed by their thoughtful and impactful contributions in government, non-profits, and business. Phoua was killed senselessly on July 17, 2022, in a hit-and-run accident that has forever changed countless lives. I hold Phoua, her family, and our community in my heart as we honor her incredible legacy.
