Mr. KELLY of Mississippi. Madam Speaker, I rise today to honor the life of Jerry Clayton. Jerry was born on August 28, 1938, in the

Mount Vernon community of Lee County to Robert Curtis and Dewdrop Raper Clayton. He graduated from Belden High School and attended Itawamba Junior College (IJC) and Florence State (UNA) on basketball scholarships. While at IJC he met Tula Ann Senter and they were later married. After earning a degree from Mississippi State, he began teaching History and coaching basketball at Milam Jr. High School in Tupelo. Little did he know then that his heart for teaching would be a driving force throughout his life. Coaching took him to Tupelo High School where his 1968 Golden Wave basketball team won the state championship. He cherished his relationship with his students and players and remained concerned about them through the years, often being invited to their class re-

In 1968, Jerry left the school system to become Chancery Clerk of Lee County, an office he served for twenty years. He was active in the Mississippi Chancery Clerks Association and often helped new clerks learn office operations. While in office he was appointed Youth Court Referee. There his experience with abused and neglected boys revealed a need for a safe place to house and nurture these young men. This became his mission and with support of the Lee County Board of Supervisors, Jerry founded the Alpha House, where for the next forty years, boys found a mentor whose goal was to give them a new way of life with confidence to set a goal and reach it. He wanted them to be so successful that they would become taxpayers instead of tax recipients. Many of those young men who lived there often came back to see and thank him.

Wherever his careers took him. Jerry remained dedicated to his family. He taught his two sons to love the outdoors, and they hunted and fished together and loved all things MSU. His terrific sense of humor made for many stories of their adventures. All the while his example taught them to care for those less fortunate. Jerry was a member of the original Elvis Presley Memorial Foundation Board, a Mason, and served on the board of the North Mississippi Medical Center. In 2014 he was named Tupelo's Outstanding Citizen. Jerry is survived by his wife of sixty-four years Tula, his sons Clay (Lisa) and Matt (Donna), his grandchildren Jacob Washington (Rachel), Davis Clayton (Kelsey), Grace McClay Clayton, Carter Clayton (Anna Grace), Walker Clayton and Anna Kees Clayton and four great grandchildren: Knox, Graham, Eve and Stella. He is also survived by his nephews Brad and Robbie Clayton.

He was preceded in death by his parents and his brother Joe Clayton.

HONORING THE SERVICE OF TEXAS STATE SENATOR LARRY TAYLOR

Mr. BABIN. Madam Speaker, I rise today to honor the service of my friend, Senator Larry Taylor, who admirably served two decades in the Texas Legislature as State Representative for House District 24 from 2003 to 2013 and as State Senator for Senate District 11 from 2013 to today. Senator Taylor will retire after a distinguished career at the end of this current session in early 2023.

Senator Taylor was raised in Friendswood, Texas, and is a lifelong Texan and Baylor University graduate. He and his wife, Kerri, have three children and five grandchildren. Senator Taylor formerly owned Truman Taylor Insurance Agency in Friendswood, an independent agency started by his father more than 50 years ago.

Senator Taylor served five sessions in the Texas House of Representatives before his election to the State Senate. During the 82nd Legislature, Representative Taylor served on the Texas Sunset Advisory Commission, a 12-member body made up of legislators and members of the public who are appointed by the Lieutenant Governor and the Speaker of the House of Representatives and are tasked with identifying and eliminating waste, duplication, and inefficiency for more than 130 Texas state agencies. As a House member, he also served on the following committees:

Elections, Insurance, Voter Identification and Fraud Select Committee, Windstorm Insurance Oversight, Emergency Preparedness Select Committee, Special Purpose Districts Select Committee, Ways and Means, Appropriations, Calendars, Hurricane Ike Storm Devastation to the Texas Gulf Coast Select Committee, Property Tax Relief and Appraisal Reform Select Committee, Business and Industry, House Administration, Health Insurance Risk Pool Deficit, Windstorm Coverage and Budgetary Impact, and Public Health.

Senator Taylor has served five sessions in the Texas State Senate and spent four of those sessions as Chairman of the Senate Committee on Education. He also served as Chair of the Senate Finance Article III working group and was a member of the important Budget Conference Committee, a select group chosen to ensure that legislators passed a balanced budget. Additionally, he is a member of the Legislative Budget Board, a permanent joint committee responsible for developing budget and policy recommendations for legislative appropriations. Senator Taylor has served on the following Senate committees:

Education, Finance, Future of College Sports in Texas Select Committee, Higher Education, Ports Select Committee, Veteran Affairs, Water, Agriculture, and Rural Affairs, Coastal Barrier System, Mass Violence Prevention and Community Safety Select Committee, Texas Commission on Public School Finance, Cruise Industry Development, Business and Commerce, Intergovernmental Relations, State Real Property Data Collection, Reporting and Assessment Select Committee Government Organization. Health and Human Services, Education Policy for a Skilled Workforce, Texas Lottery and Texas Lottery Commission, and Violence in Schools and School Security Select Committee

In 2020, Senator Taylor was named "Galvestonian of the Year" by the Galveston Chamber of Commerce. Two years later, he was given the 2022 inaugural "Senator Larry Taylor Champion of Education" award by the League City Chamber of Commerce for his tireless advocacy on behalf of Texas students and teachers. He currently serves on the board of Hope Village, a residential and day program for people with developmental disabilities, and as the Director and Chairman of the Board for Texan Bank. He is also President of the Texas Conservative Coalition Research Institute Board.

Madam Speaker, I would like to commend my good friend Senator Larry Taylor for his many years of faithful service and dedication to the State of Texas, his constituents, and the education of countless Texans. I would also like to congratulate him on an outstanding career and wish him, his wife, Kerri, and their family the best in his retirement and future endeavors.
