We pray that You would reveal Your way through the hostility of critical negotiations. Do not hide Your face in the confrontation of ideology, ideations, and indifference which portend widespread human suffering, untold destruction to the welfare of an entire country, and instability in the region and across the globe.

We hold firmly to Your promise that we "shall see the goodness of the Lord in the land of the living." O Lord, our God, fulfill this promise in our broken world this day.

We offer this prayer in Your sovereign name.

Amen.
