ELECTING A MEMBER TO A CERTAIN STANDING COMMITTEE OF THE HOUSE OF REPRESENTATIVES

Ms. STEFANIK. Madam Speaker, by direction of the Republican Conference, I offer a privileged resolution and ask for its immediate consideration.

MEDICARE PREMIUM INCREASE

(Mr. COURTNEY asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. COURTNEY. Madam Speaker, on November 12, Medicare announced the largest part B premium increase in the history of the Medicare program, 14 percent. This could not come at a worse time in terms of, again, the cost of living that many seniors are facing.

Looking closely at that decision, one of the driving factors was the projected cost of the drug Aduhelm, which was priced at \$56,000 per year for Alzheimer's patients who were, again, very excited about the possibility of getting the benefit of that drug. But the cost of that drug was one of the big driving forces for a 14 percent rate increase.

On December 20, Biogen, the manufacturer, cut the cost of that drug from \$56,000 to \$28,000. About 2 weeks ago, Secretary Becerra correctly instructed the actuaries of Medicare to go back and try and recalculate the Medicare part B premium to see if there was a way to get some relief for seniors from that 14 percent rate increase.

Today, 31 Members of the House Democratic Caucus are sending a letter to Secretary Becerra again applauding his decision and strongly advocating that Medicare go back in and recalculate that rate increase, which will provide tremendous assistance for seniors at exactly the time that they need it.

RECOGNIZING LIEUTENANT JASON
MOLONEY

(Ms. VAN DUYNE asked and was given permission to address the House

for 1 minute and to revise and extend her remarks.)

Ms. VAN DUYNE. Madam Speaker, I rise today to recognize Lieutenant Jason Moloney and the Southlake Fire Department for their selfless acts of service to protect our State during the recent wildland fire deployments.

Over the holiday season, Southlake Fire Department personnel took part in two different deployments as part of the Texas Intrastate Fire Mutual Aid System to assist with wildland fires in the Texas panhandle. The fire covered nearly 24,000 acres and stretched 23 miles long.

Southlake Fire Department Lieutenant Jason Moloney fearlessly served as the Strike Team Leader of a specially trained team, which included five wildland brush trucks and a command vehicle.

During the second deployment, the strike team was deployed on January 4 and was safely demobilized on January 9. While Lieutenant Moloney was on the front line, his wife, Velvet, worked tirelessly treating COVID-19 patients as a respiratory therapist and taking care of their two young children. ANNOUNCEMENT

After Harry's initial appointment in 2005, the people of Alexandria reelected Harry to the council four times.

At the time of his retirement, Harry was both the oldest active elected official in the United States and the oldest elected official in Louisiana history.

In his farewell message to the city, Harry said: "Whether you or your parents, grandparents, or great-grandparents agreed with me or not over the years, I hope everyone agrees that I acted only as I felt was best for our mutual home."

Madam Speaker, that is all that we can ask of a public servant.

RECOGNIZING NATIONAL SCHOOL
CHOICE WEEK

(Mr. MOOLENAAR asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. MOOLENAAR. Madam Speaker, over this past weekend, the Democratic Party in my home State published a graphic saying public schools do not exist to serve the parents of those students and, rightfully, there was an outcry before they took it down and disavowed what they posted.

Parents absolutely have the right to know what their kids are learning, and over the past year and a half they have been fighting back against administrators and unions who have kept students out of the classroom.

When public school teachers in Chicago went on strike earlier this month, the phones rang off the hook at the city's private schools as parents finally had enough and searched for classroom opportunities for their kids.

Support for parental involvement in education and for school choice has risen over the past year, and my colleagues and I will soon be introducing a resolution to honor National School Choice Week that will be next week, from January 23 through January 29.

Parents and students should be given every opportunity to find a classroom where the kids can attend in person, see their friends, and learn directly from a teacher.
