for them. It is one of life's great enigmas that Republicans can keep a straight face while they simultaneously cite the deficit to extort massive spending cuts to critical programs and support a bill that would blow up deficits to extend trillions in tax cuts for the people who need them the least.

Three and a half trillion dollars is an evepopping long-term price tag for the Trump tax law that Republicans swore up and down would pay for itself," Wyden said. "Republicans who say they're worried about the deficit have brought our economy on the brink of default, and yet they want to run up the debt by locking in the Trump tax law that remains horribly skewed toward corporations and the wealthy. The Republican game plan is clear. For every penny they give in tax handouts to the rich, down the road they're going to demand equivalent cuts that boot people off their health care, increase child hunger, and raise the cost of living for typical Americans.

According to the Institute on Taxation and Economic Policy, extending the Trump tax cuts would create a windfall for the top 5 percent of income earners, who would receive nearly 40 percent of the benefits in the first year alone, making this legislation one of the most regressive and expensive tax giveaways in history. The average taxpayer in the top 1 percent would save nearly \$26,000 in just that first year.

CBO's previous cost estimate for extending the Trump tax cuts was \$3 trillion through 2032, but the 10-year budget window now includes more years post-expiration. The new estimate is part of a larger report analyzing alternative assumptions about spending and revenues. It also includes a projection that permanently extending the enhancements made to the Affordable Care Act's premium tax credits—originally enacted in 2021's American Rescue Plan Act and extended through 2025 by 2022's Inflation Reduction Act—would cost \$300 billion, a fraction of the cost of extending the Trump tax cuts.

# HONORING OUR COMMITMENTS TO OUR VETERANS

(Mr. OBERNOLTE asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. OBERNOLTE. Madam Speaker, I rise to thank this body for passing my bill, the Streamlining Aviation for Eligible Veterans Act, or SAFE Veterans Act, as part of the VET-TEC reauthorization bill that the House passed this week.

This bill will make a meaningful contribution to allowing more of our veterans to receive vocational flight training and enter our Nation's workforce as pilots following their service in our military.

Madam Speaker, in 1980, over twothirds of our Nation's pilots were veterans. Today, that number is less than 30 percent. This bill will not only ameliorate that situation but also help us honor the commitment that we have made to those who served in our Armed Forces.

Madam Speaker, I urge its passage in the Senate and its transmittal to the President, and I thank this body for supporting it.

## REPUBLICAN DEFAULT CRISIS: VETERANS

Ms. PELOSI. Madam Speaker, this weekend, our Nation will solemnly observe Memorial Day to honor our fallen heroes and their families.

Instead of this honoring of our veterans, shamefully, the Republicans across the aisle will spend the weekend working to impose suffering on our valiant veterans.

The Republicans have forced Americans down a treacherous path to accept their extreme proposal, which would eliminate 30 million health visits for our veterans and slash revenues at the VA.

It would trigger a catastrophic default, which would force our Nation to stiff veterans on the benefits they have earned. That also applies to the effect it would have on America's middle class.

## DEBT CEILING CRISIS

Mr. LAMALFA. Madam Speaker, we are 1 week away from Secretary Yellen's hard default date, the June 1 deadline.

House Republicans have been calling on our colleagues on the other side of the aisle and the President to be negotiating on this debt since January. It is now May 25. In the past 140 days, we have been hearing a lot of name-calling and little bipartisan negotiation.

While this impasse has dragged on, House Republicans passed legislation, the Limit, Save, Grow Act, that averts a default and reduces wasteful spending. Let's negotiate from that point.

In my district, an estimated 95,600 households with Social Security checks are at risk.
