#### ENDING WEAPONIZATION OF LAW ENFORCEMENT AGENCIES

Mr. CLINE. Mr. Speaker, for years, Americans have watched their televisions or read their newspapers and seen the FBI constantly in the headlines—and not for the good.

Under Director Christopher Wray's leadership, the FBI has become weaponized, and the American people's trust in the institution has been severely damaged. We have seen the agency launch an entirely unwarranted investigation against Donald Trump to prove nonexistent collusion with Russia.

We have seen the agency use the Steele dossier to abuse the FISA process and spy on conservatives.

We have seen the agency label parents concerned about what their children are learning in schools in Northern Virginia as domestic terrorists.

We have seen the agency target whistleblowers who expose corrupt behavior and political bias.

We have seen the agency target Catholics in Richmond, Virginia, who are simply exercising their First Amendment right to express their faith.

The Republican-led House Judiciary Committee is demanding that Director Wray accept responsibility for the agency's abusive overreach of power,

and the Appropriations Committee is taking action, using the power of the purse to rein in the abuses that have occurred in this agency.

There is no place for politics within the FBI, and we will not stop working to bring an end to this weaponization of our law enforcement agencies and the use of these agencies against law-abiding Americans.

#### RECOGNIZING THE EPOCH TIMES

The SPEAKER pro tempore. The Chair recognizes the gentleman from South Carolina (Mr. NORMAN) for 5 minutes.

Mr. NORMAN. Mr. Speaker, when John Tang was earning his doctoral degree in physics at Georgia Tech in 1999, he never imagined that some 20 years later he would be heading the fourth largest American newspaper by subscription count.

At the time, the Chinese Communist Party, the CCP, had just started persecuting the spiritual discipline Falun Gong, practiced at the time by roughly 1 in every 12 Chinese. People would practice the slow-moving exercises in the morning in parks before going to work.

Just like any other persecution campaign by the CCP, the regime relied on the media it controlled, both the state media and the private media, to demonize and isolate the group. In an attempt to demonize Falun Gong and justify its persecution, the media played nonstop hate propaganda attacking this peaceful meditation group.

John, who had immigrated to the United States, watched from afar in horror as friends were persecuted for their beliefs.

John decided to take action. Despite having no experience or investment, he started Dajiyuan, the Chinese edition of The Epoch Times, in the basement of his home in the suburbs of Atlanta, Georgia.

John was driven by a wish to provide uncensored information to not only people in China but to people around the world. Soon, other Chinese Americans left their well-paying jobs to help John with this seemingly impossible endeavor.

The Epoch Times' first reporting group was established in China in the year 2000, covering key events with a main focus on the CCP's human rights abuses. The CCP, however, sees any kind of independent reporting on its brutal human rights abuses as a threat. Within a few months, Chinese police raided the underground newsroom, arresting every reporter and every editor. They were imprisoned, specifically

Zhang Yuhui and Shi Shaoping, who received sentences of 10 years where they faced frequent torture.

The Epoch Times' China operation went underground, yet the Chinese edition quickly became a leading website on Chinese current events with millions of readers. Its print newspaper is now distributed nationwide as well as in 30 other countries around the world. Every day, many Chinese break through the CCP's internet firewall to read The Epoch Times' website.

All of this has not been easy. Since the newspaper's founding, the CCP has waged a nonstop campaign to totally destroy it. The party has threatened the newspaper's advertisers, they have launched incessant cyberattacks on its website and IT systems, and threatened relatives of staff members back in China.

The harassment has not been limited just to China. In 2006, the home of then-chief engineer Peter Li was broken into by assailants, who tied him to a chair and beat him before stealing two computers.

Meanwhile, in Hong Kong in 2019, assailants started a fire in the newspaper's printing press, and in 2021, armed men entered the building and used sledgehammers to smash printing equipment.

The Epoch Times also inspired the Tuidang, which means "Quit the CCP" movement. As a result of The Epoch Times' publication of this special series "Nine Commentaries on the Communist Party," which provides the most thorough interview to date of the true nature of the CCP, more than 410 million Chinese people, and counting, have sought to sever their membership in this party and its affiliated organizations.

#### REPUBLICANS CHOOSE CULTURE WAR OVER NATIONAL SECURITY

The SPEAKER pro tempore. The Chair recognizes the gentlewoman from Michigan (Ms. SLOTKIN) for 5 minutes.

Ms. SLOTKIN. Mr. Speaker, later today we will begin voting on the NDAA, the National Defense Authorization Act, the Pentagon budget.

Moving this legislation forward has almost always been a bipartisan issue in Congress. It takes on the responsibilities of funding our military. It protects our national security. It has been a bipartisan effort for nearly six decades.

But last night, after midnight, Republican leadership decided to bring to the floor dozens of partisan divisive amendments. If adopted, these amendments would transform this bill and transform our military. It is quite literally a wish list of the rightwing extremist colleagues on the other side of the aisle.

There is an amendment to end all affirmative action in our officer corps, something even our Supreme Court refused to do just a few weeks ago. There is an amendment to full stop, end all aid to Ukraine, at the very moment we are expanding NATO and working on protecting democracy abroad on behalf of all democracies.

Another one that they passed was a divisive amendment that prevents female servicemembers in the military from accessing the reproductive care that they need and they deserve. Plain and simple, last night, they chose culture war over national security, and they are doing so as part of a clear effort to prevent every single American woman from accessing care. It is part and parcel of a larger campaign to impose a nationwide ban on abortion.

Last night, like I said, in the dead of night, the Freedom Caucus passed this amendment to stop the military from paying for a bus ticket or a plane ticket for any woman who needs an abortion, and it is proof of this bigger plan.

In addition to this amendment that passed last night, we have amendments in the Appropriations Committee that are the same thing.

We have a single Senator, Senator TUBERVILLE, who is holding and blocking 250 military promotions right now, the head of the Marine Corps, the head of the Army, the head of the Navy, because he objects to the fact that a woman might get a paid bus ticket to get an abortion.

If blocking these nominations continues, we will have no Chairman of the Joint Chiefs, no commandant of the Marine Corps for the first time in 134 years, no Army chief of staff. His colleagues, who claim to care about national security, are letting him get away with it. Now, they have used this bipartisan bill in order to make their point.

Forty-six percent of Active Duty servicewomen are stationed in States that now either ban or very severely restrict abortion. They have no choice. They are based there. They have signed up to serve their country. They have been put on a base in Texas or Alabama. That is not their choice. That is their duty.
