HONORING THE CITY OF RIO VISTA

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor the 130th anniversary of the City of Rio Vista.

In 1877, the first consideration of Rio Vista's incorporation began. At that time, concerns that expensive improvements would be brought against the wishes of the citizens led to the postponement of further consideration of the matter. By 1892, the citizens reached a consensus regarding the necessity of incorporation. Incorporation allowed Rio Vista to establish a Board of Trustees with the power to pass ordinances, purchase and lease property for municipal purposes, contract for the supply of water, improve streets and sidewalks, provide fire apparatus, impose and collect dog license fees and property taxes, and perform other similar duties.

A petition was drafted describing the boundaries of the proposed incorporation. However, just before the petition was scheduled to go before the Solano County Board of Supervisors in May of 1892, it was discovered that the voter registry did not meet legal qualifications and would need to be updated.

Following this, a second petition circulated in November of 1893, with an election scheduled for December 30, 1893. The population at the time was approximately 650. Of those 650, 129 were eligible voters. That day, 121 were polled, with a majority supporting incorporation.

On January 3, 1894, the Board of Supervisors canvassed the votes. As there was a majority, the Board declared the Town of Rio Vista a municipal corporation, and named the first Board of Trustees, Treasurer, Clerk, and Marshal.

In the time since the vote, the population in Rio Vista has grown substantially. Today, there are over 10,000 residents. Since incorporation, numerous notable events have occurred. In 1968, Rio Vista became the City of Rio Vista rather than the Town of Rio Vista. In 1985, Rio Vista gained national attention when Humphrey the Whale deviated from his migratory route, ending up in Rio Vista. In 1989, the Rio Vista Municipal Airport was built, providing residents with more convenient access to flights.

Today, the City of Rio Vista is a sanctuary for those seeking a slower paced atmosphere. A popular location for many wildlife enthusiasts, bird watchers, fisherman, and wind surfers, Rio Vista is surrounded by beautiful rivers. Rio Vista is also the largest producer of Belgian Endive in the United States.

Mr. Speaker, as our community now commemorates this momentous anniversary, we celebrate the history of the City of Rio Vista. It is therefore fitting and proper that we honor the City of Rio Vista here today.

ENERGY AND WATER DEVELOPMENT AND RELATED AGENCIES APPROPRIATIONS ACT, 2025

SPEECH OF

HON. ROBERT C. "BOBBY" SCOTT

Mr. SCOTT of Virginia. Mr. Chair, I rise today in support of my amendments to H.R. 8997, the Energy and Water Development and Related Agencies Appropriations Act for Fiscal Year 2025.

These two amendments support essential funding for our National Labs and specifically for the Continuous Electron Beam Accelerator Facility, or CEBAF, at the Thomas Jefferson National Accelerator Facility, commonly known as JLab, in Newport News, Virginia. CEBAF is a world-leading facility studying the inner properties of nuclei, such as the quark and gluon structure of protons and neutrons. The research conducted at this facility has vastly improved our understanding of the fundamental make-up of matter and is actively supporting collaborative research globally in medium energy physics.

The first amendment highlights the need for funding critically needed infrastructure improvements at CEBAF. The workforce at JLab is rapidly growing with the increased use of CEBAF and the installation of the Department of Energy's High Performance Data Facility. For JLab to effectively support its employees and researchers, the lab needs increased funding to build a modern workspace to match the research conducted at this facility. The final appropriations bill should include \$32 million for JLab to update its CEBAF infrastructure.

The second amendment highlights the importance of an optimal runtime for CEBAF.
