#### PUBLIC BILLS AND RESOLUTIONS

Under clause 2 of rule XII, public bills and resolutions of the following titles were introduced and severally referred, as follows:

> By Mr. BEYER (for himself and Mr. Luem):

H.R. 9954. A bill to prohibit use of remote biometric surveillance technology on any data acquired by body-worn cameras of law enforcement officers, and for other purposes; to the Committee on the Judiciary.

By Mr. BURCHETT (for himself and Mr. GAETZ):

H.R. 9955. A bill to amend the Foreign Assistance Act of 1961 to modify the Presidential drawdown authority, and for other purposes; to the Committee on Foreign Affairs, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mr. CARTWRIGHT:

H.R. 9956. A bill to amend the Internal Revenue Code of 1986 to provide for the proper tax treatment of personal service income earned in pass-thru entities; to the Committee on Ways and Means.

By Mr. CURTIS (for himself, Ms. MALOY, Mr. MOORE of Utah, and Mr. OWENS):

H.R. 9957. A bill to direct the Secretary of Energy to conduct a study of the feasibility of establishing a refined fuel storage reserve in the Western United States: to the Committee on Energy and Commerce.

By Mr. CURTIS:

H.R. 9958. A bill to amend the Internal Revenue Code of 1986 to permit certain transactions between individually directed accounts and account holders and their families relating to residential property and to
