month after a courageous battle with cancer. John lived a full life with a deep commitment to service.

John served with Tempe Fire Medical Rescue for twenty years. He responded to countless emergencies and delivered lifesaving care to thousands of Arizonans. He served several roles, from paramedic to captain, to engineer, and took pride in mentoring younger fire-fighters. Colleagues remember his solid judgment, quick thinking, and a steady presence he brought to even the most difficult calls. His last assignment, Engine 273 at Station 3, was a place where he earned the respect and friendship of everyone he served with.

John's dedication to the people of Tempe extended far beyond the calls he answered. A proud graduate of Tempe High School, he knew the neighborhoods, families, and history of this community as well as anyone. Fellow firefighters describe the warmth he brought into every room, the humor that lifted spirits on hard days, and the genuine kindness that made people feel seen and appreciated. He was the kind of public servant who led by example, placing others first and treating every person with respect and dignity.

Love of country and a belief in service shaped his life well before joining the fire department. As a United States Marine, John embodied courage, discipline, and devotion to country. He brought those values with him throughout his life and showed tremendous work ethic, passion, and pride in helping others. He possessed those same traits as a husband, father, and friend. Outside the firehouse, he found joy in the outdoors, whether hunting, fishing, camping, cooking, or golfing with the people he loved.

John is survived by his wife, Liana; his children, John Jr. and Maya; his parents, Robert and Nora; his sister, Elizabeth, and her children, PJ and Brooke. He leaves behind extended family, fellow Marines, and generations of firefighters who admire his character and carry his example into their own service.

Tempe is a better place because of John. He saved lives and selflessly uplifted those who had the privilege of knowing him.

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Nimbus Arts as it celebrates its 20th anniversary. Founded in 2005 by Jamie Graff and Dana Johnson, Nimbus Arts has become an intrinsic part of our community, providing art education and fostering creative expression throughout our Napa Valley

The idea for Nimbus Arts was born out of a deeply personal experience. When Ms. Johnson's daughter was undergoing treatment at UCSF Children's Hospital, she witnessed the healing power of art through the hospital's family art programs. Wanting to bring that same sense of connection and creativity to her own community, Ms. Johnson partnered with fellow Napa Valley resident Jamie Graff and Janet Pagano, Executive Director of The Cantus Fund, to create an accessible, community-serving art center. Ms. Graff took on the role of Executive Director, and Nimbus Arts was launched in 2005, operating at first from borrowed spaces in churches and schools.

Today, Nimbus Arts has grown into a \$1.7 million enterprise with three well-equipped studios, including a dedicated ceramics and metal arts facility. The organization offers more than 800 classes and events annually to a diverse group of students, from toddlers to retirees. The organization works within public school systems providing arts activities on campuses and also works in court and community schools, including at Napa's Juvenile Hall, where art serves as a tool for self-expression and emotional exploration. Through its Hundreds of Hands initiative. Nimbus Arts coordinates large-scale community-based free public art projects throughout Napa Valley. The organization employs more than 40 artist instructors, many of whom have been with Nimbus since its founding.

Nimbus Arts' success is a direct reflection of the vision and dedication of its co-founders. Under Ms. Graff's leadership as Executive Director, Nimbus Arts has developed classes, camps, and workshops across disciplines ranging from painting and glass fusing to sewing and culinary arts. She also launched the Nim+BUS, a mobile art studio that delivers hands-on art experiences to schools and community events across our Napa County. Ms. Graff also worked with the board and staff to establish NIMBASH, the organization's annual gala and fundraiser. Her leadership has helped make Nimbus Arts a hub of creativity and collaboration, earning her recognition as Napa County's 2015 Arts Hero. Ms Johnson

has served as Board President since Nimbus Arts' founding, bringing business, marketing, and fundraising expertise to the organization. She plays an active role in its ongoing success, participating in NIMBASH and serving on the Finance, Fundraising, and Vision Committees. Beyond Nimbus Arts, Ms. Johnson has also served as a Board Commissioner for the St. Helena Public Library and held positions with The Alex Fund, The Alpheios Project, and The Cantus Fund.

Supporting local artists through meaningful employment and exhibition opportunities remains central to Nimbus Arts' mission. Ms. Graff is currently leading expansion efforts in south Napa, including the establishment of a new studio and a partnership with the Napa Valley Education Foundation to bring arts programming to the Foundation's new Discovery Campus. In recognition of its contributions to community life, Nimbus Arts was named St. Helena's Non-Profit of the Year in 2020.

Mr. Speaker, for 20 years, Nimbus Arts has served as a vibrant hub for community members of all ages and backgrounds to enrich their lives through art, The Nimbus Arts team's commitment to making art accessible to everyone has transformed countless lives and I am so grateful for their dedication to our community. I look forward to watching this creative community continue to grow for the next 20 years and beyond. Therefore, it is fitting and proper that we honor them today.

HONORING THE LIFE AND LEGACY OF LUCILLE HOBACK BOGGESS

Mr. GRIFFITH. Mr. Speaker, I rise today to recognize the life and work of Bedford County icon Lucille Hoback Boggess, who passed away on November 19, 2025, at the age of 96.

On June 8, 1929, Ms. Hoback Boggess was born into the Hoback family. The Bedford County family would eventually consist of 7 children.

While Ms. Hoback Boggess was attending Bedford High School, some of the Hobacks were serving the United States Armed Forces during World War II.

Unbeknownst to her, as Ms. Hoback Boggess was preparing to celebrate her 15th birthday in Bedford, Virginia, her brothers Bedford and Raymond were preparing for a heroic mission to break Fortress Europe and push back against Nazi tyranny.

Two days before her birthday, Bedford and Raymond stormed Omaha Beach as part of Company A, 116th Regiment, 29th Division. They were at the point of the sphere of the Allied D-Day landings in Normandy.

While Allied forces would prevail over their enemies, Bedford and Raymond would lose their lives that day on Omaha Beach. Her brothers were two of the 20 lives lost from Bedford, Virginia.

The Bedford community suffered the most deaths per capita than any other American community on June 6, 1944. Today, these patriots are better remembered as the Bedford Boys.

Ms. Hoback Boggess and their family would not learn of their brothers' deaths for weeks.

While enduring this family hardship, Ms. Hoback Boggess sustained her educational progress. She graduated from Bedford High School and later attended Lynchburg's Phillips Business College.

Following these experiences, Ms. Hoback Boggess pursued a lengthy career with the Bedford County Commissioner of Revenue's office. She developed great institutional knowledge from working for the Commissioner of Revenue, helping prepare state and federal tax returns and eventually running much of the daily office activities.

Thanks to this work, Ms. Hoback Boggess believed she could serve the County in an enhanced role. And the people of Bedford County believed in her.

In 1967, Bedford County residents elected Ms. Hoback Boggess as Commissioner of Revenue. She was the first-ever woman elected to countywide office in Bedford County.

As a popular official, Ms. Hoback Boggess continued to earn the trust of Bedford County residents. Her leadership as Commissioner of Revenue continued for decades.

In 1991, Bedford County entrusted Ms. Hoback Boggess with a new office. She was elected to the Board of Supervisors with a resounding 3-to-1 margin. Ms. Hoback Boggess once again made history, becoming the first female to serve the Bedford County Board of Supervisors, eventually becoming Chairman.

A 1997 Roanoke Times article credits Ms. Hoback Boggess as Bedford County's most popular and skilled elected official with reputations as a compassionate listener, moderator and peacemaker.

Ms. Hoback Boggess' service to Bedford County spanned over 60 years. While her public service alone would be worthy of commendation, one of her most cherished and celebrated roles was her help in remembering the sacrifices of her brothers.

Ms. Hoback Boggess dedicated significant attention, time, and effort to engage, memorialize, and pay respects to those who served on D-Day, including her two brothers. Her help along with Bob Slaughter culminated in the founding and creation of the National D-Day Memorial, located in Bedford, Virginia.

It was during this time that I had the honor of meeting Ms. Hoback Boggess when my friend Delegate Lacey Putney introduced me to her while she was lobbying Virginia's General Assembly to support state funding for the National D-Day Memorial.

The National D-Day Memorial is a significant symbol for Virginia. It represents service, grit, honor, sacrifice and much more.

Not only did Ms. Hoback Boggess cherish her brothers, but she dutifully tended to and cared for her family. Her loving marriage to Ralph Boggess lasted nearly 60 years, cut short by his death in 2007. Ms. Hoback Boggess is survived by her children: Carl (Lynn), Ann (Dwayne), John (Ryan), and David (Robin). She is also survived by grand-children, great-grandchildren, nieces, nephews, former tax customers, and fans around the world.

Today, we celebrate the inspirational legacy of Ms. Lucille Hoback Boggess. Her remarkable tenure as an elected official and National D-Day Memorial advocate are to be commended. I join Bedford County and Virginia in mourning the loss of this beloved figure.

Ms. NORTON. Mr. Speaker, today, I introduce of a bill that would require the Library of Congress (LOC) to install the District of Columbia seal in the Main Reading Room of the Thomas Jefferson Building of the LOC. Specifically, the bill would require the LOC to install a stained glass panel depicting the D.C. seal among the panels depicting the seals of all the states and territories that existed when the Thomas Jefferson Building was constructed. The seals of Hawaii and Alaska are
