SUPPORTING THE PROSPER IN THE PACIFIC ACT

Mr. CASE. Mr. Speaker, I rise today in support of my Promoting Regional Opportunities for Sustainable Prosperity and Economic Resilience in the Pacific Act, or PROSPER in the Pacific Act, to advance the U.S.-Pacific Islands relationship to include an economic partnership built on shared values and principles.

The Pacific Islands, spread across the vast Pacific Ocean, have a collective maritime area that exceeds the land area of Russia and China combined. These jurisdictions are key partners in maintaining a free and open Indo-Pacific and meeting vital security and economic challenges. It is imperative that we develop, maintain, and grow these relationships.

Recognizing this, successive administrations have committed to deepening U.S. engagement in the region, including through trade and investment. Most recently, the 2025 National Security Strategy asserts that "the Indo-Pacific is already and will continue to be among the next century's key economic and geopolitical battlegrounds," reaffirms our commitment to a free and open Indo-Pacific and prioritizes winning the economic competition over the long term in the region. Additionally, the U.S.-China Economic and Security Review Commission's 2025 Annual Report to Congress recommended that we strengthen economic assistance to Pacific Island countries to support U.S. national security interests and the priorities of partner countries.

However, our economic toolkit for achieving our goals in the Pacific Islands needs to be strengthened, Many Pacific Island countries enjoyed preferential treatment under the Generalized System of Preferences (GSP) when it was authorized, but the program lapsed in 2020. Some of the Pacific Islands' top exports to the U.S., including tuna, cane sugar, ginger

and taro, would be eligible for duty-free treatment under GSP but for this lapse.

The Pacific Islands Forum (PIF), the leading multinational political organization for the Pacific Islands region, has prioritized the region's need to build trade capacity and infrastructure and has specifically advocated for preferential trade agreements given its lack of competitiveness due to its small national markets, isolation from the global market, and high cost of operating and land and labor constraints. The PIF has encouraged the U.S. to extend dutyfree treatment under the GSP beyond preferences for Least Developed Beneficiary Developing Countries.

Implementing such a program would come at a low cost to the U.S. while delivering a high strategic return, especially given the People's Republic of China's (PRC) increased focus on expanding its influence in the region. My bill, PROSPER in the Pacific, would provide a visible alternative to the PRC by emphasizing economic partnership over debt-trap diplomacy, all while encouraging private-sector-led development, market-based economies, and goodwill towards the U.S.

The PROSPER in the Pacific Act would authorize the President to designate certain articles imported from eligible Pacific Island countries for duty-free treatment, extending to them the same preferential access that is afforded to least developed beneficiary developing countries under GSP. By doing so, my legislation aims to stimulate export opportunities for Pacific Island economies while encouraging U.S. businesses to source more goods from the region. In addition to expanding market access, the bill would direct the President to develop a comprehensive plan for negotiating free trade agreements with Pacific Island countries that express interest, laying the aroundwork for deeper, long-term economic integration. Finally, my bill would create a dedicated trade facilitation and capacity-building program for the Pacific Islands to help partner governments strengthen customs procedures, meet U.S. product standards, and improve overall export readiness, ensuring they can fully realize the benefits of enhanced trade ties.

I urge my colleagues to join me in supporting this legislation to sustain and expand U.S. economic and security engagement in this critical region.

Mr. MFUME. Mr. Speaker, I rise today to honor Ms. Denyce Graves—world-renowned mezzo-soprano, visionary stage director, and tireless advocate for arts education—who has dedicated her career not only to performance, but to inspiring, uplifting, and empowering the next generation of artists.

Ms. Graves was raised in Washington, D.C., by her mother, Dorothy Graves-Kenner, a fierce believer in education. Dorothy assigned her children weekly enrichment projects and nurtured Denyce's early affinity for music—first in the church choir, and later in elementary school.

In elementary school, Ms. Graves experienced the transformative power of mentorship through her music teacher, Judith Grove, who recognized her talent and followed her all the way through high school. She attended the Duke Ellington School of the Arts, where she was introduced to classical music—and promptly fell in love with the art form.

After high school, Ms. Graves continued her studies at Oberlin College and Conservatory and at the New England Conservatory of Music, where she honed her vocal technique and deepened her understanding of performance.

Ms. Graves' early career was marked by both triumph and setbacks. She impressed at the Metropolitan Opera's regional auditions, but fell short in the finals, leading her to take a break from singing and work as a hospital secretary. Just as she began to consider leaving music behind, the Houston Grand Opera reached out and invited her to their young artists program, rekindling her career and setting her on a course for the world stage.

Shortly thereafter, Ms. Graves took the world by storm, captivating audiences at the Bastille Opera House in Paris, the Vienna State Opera, and other major houses across Europe and the Americas. Her growing international acclaim culminated in 1995, with her landmark Metropolitan Opera debut in the title role of Carmen. She brought to the role a gravitas and a fiery intensity that critics lauded as a defining interpretation. She brought that same commanding presence to the stage as Dalila in Samson et Dalila, establishing herself as one of the great operatic superstars of the modern era.

Throughout her career, Ms. Graves has been honored repeatedly for her artistic achievements and philanthropic leadership. She has won an Emmy and a Grammy, as well as the Washington Performing Arts' Ambassador of the Arts Award, She was named a U.S. Cultural Ambassador, sang at the National Prayer Service following the September 11, 2001, terrorist attacks, and performed at President George W. Bush's second inauguration. Most recently, she received the Service to America Leadership Award from the National Association of Broadcasters Leadership Foundation, in recognition of her unwavering dedication to public service through the arts.

These honors reflect not only Ms. Graves' extraordinary talent, but also her commitment to using her talent in service of others. She is a teacher and mentor at the Juilliard School. the Peabody Conservatory, and the University of Toronto. She founded the Denyce Graves Foundation in 2021, with a two-pronged mission: to advance diversity in her field and to honor the legacies of historically overlooked voices. Their "Hidden Voices" program highlights and celebrates the artistic contributions of historically marginalized musicians, composers, and educators. Their flagship "Shared Voices" initiative connects Historically Black Colleges and Universities with top music conservatories, expanding access and fostering inclusion for the next generation of artists.

Mr. Speaker, the remarkable career of Ms. Denyce Graves reflects a rare combination of artistic excellence and passionate leadership in education. Through her performances, advocacy, and mentorship, she has opened doors for countless artists and enriched the cultural fabric of our Nation. I am proud to celebrate this visionary artist whose story will inspire generations to come.
