TRIBUTE TO DR. HENRY W. WIGGINS, JR.

Mr. DAVIS of Illinois. Mr. Speaker, I rise today to pay tribute to Dr. Henry W. Wiggins, Jr., a physician, honorable veteran, civic leader, and social activist.

Dr. Henry W. Wiggins, Jr. was born on March 18, 1933, in Clearfield, Pennsylvania, to Henry and Janie Wiggins. He graduated with honors from Clearfield High School (Class of 1951) and lettered in track, football, and basketball. He then attended Franklin & Marshall College in Lancaster, Pennsylvania, earning a Bachelor of Arts degree in Biology (Class of 1955). Following Franklin & Marshall, Dr. Wiggins attended medical school at Howard University (Class of 1959), which was followed by an internship in internal medicine and radiology at University Hospital at the University of

Dr. Wiggins admirably served our country in the United States Navy as Chief Radiologist

and Lieutenant Commander at Naval Hospital Bremerton in Bremerton, Washington. Following his military service, Dr. Wiggins served as a radiologist at Michael Reese Hospital, Mercy Hospital, Provident Hospital, Roseland Community Hospital, and St. Bernard Hospital, where he also served as Chair of the Radiology Department and as a member of the Board of Trustees. Dr. Wiggins also served as faculty at the University of Chicago Medical School.

In 1965, Dr. Wiggins marched from Selma to Montgomery in protest of voting rights discrimination. An essay he wrote about that experience expressed both his fear in facing such hatred and racism as he joined others in that march, and his bravery-knowing that it was his responsibility to "stand up and be counted" as people were denied the right to vote. He was always a man of principle who believed in doing the right thing, even when it was hard. Personally, Dr. Wiggins was a global traveler, an avid golfer, and until the very end, a die-hard Chicago Bears and Chicago Bulls fan. He was guite the bookworm, and there was not a day that went by that he did not complete the crossword puzzle or watch his two favorite shows, Jeopardy! and Wheel of Fortune.

Dr. Wiggins was preceded in death by his parents, Henry Wiggins, Sr. and Janie Wiggins, and by his siblings, Frances Sellers, Steward Wiggins, Nancy Brown, and Margaret Wiggins. He is survived by his wife, Carolynis children, Kay Lucas, Juliana Echols (Bryan), Lee Anne Young (Carl), and Henry Wiggins (Jennifer); and his siblings, Anna Wiggins, Sarah Mitchell, Mary Jane Wiggins, and Elizabeth "Libbi" Graves. He was also the joyful "PaPa" to ten grandchildren and two great-grandchildren. He leaves behind many nieces, nephews, friends, colleagues, and even strangers who benefited from his generosity and kindness.

Dr. Wiggins peacefully breathed his final breath on November 16, 2025, with his family by his side. They will carry forward his spirit, values, and devotion to community.

RECOGNIZING MR. MITCHELL GEORGE ANGELOS

Mr. PERRY. Mr. Speaker, I am honored and humbled to recognize Mr. Mitchell George Angelos of York, Pennsylvania, upon the auspicious occasion of his 100th Birthday.

Mr. Angelos' life has been dedicated to the service of our Nation. Knowing that he likely would be drafted for World War II, he finished high school in three years. He was, indeed, drafted in August 1944, and reported to Engineering Basic Training at Fort Belvoir, Virginia, where he was taught how to be an Infantryman and build Bailey modular bridges. Next,

Matter set in this typeface indicates words inserted or appended, rather than spoken, by a Member of the House on the floor. he went to Demolition Specialist School and learned how to lay mines, booby traps, and defuse those of the enemies.

At the end of his training, Mr. Angelos developed a severe infection and was taken to an Army hospital; thus separating him from his unit, which deployed to Europe while he recovered. After landing in La Havre, France, in 1945, he learned that many of his comrades from boot camp had perished in the Battle of the Bulge.

On a train to Belgium, the Soldiers were tightly packed in boxcars; as Mr. Angelos put it, like a "herd of cattle." After finally arriving in Verviers, Belgium, he fell ill and walked about a mile to sick bay; ultimately being hospitalized while the rest of the Soldiers in his unit moved on.

Eventually, Mr. Angelos landed in Marseilles, France, where his battalion prepared to deploy to the Pacific, and where he learned that the first atom bomb was dropped. Postwar, he was assigned to the Labor Supervision Battalion at Camp Calle, France, where he supervised 200 German Prisoners of War (POW) for the next seven months. He learned how to drive there, and his instructor was a German POW who "borrowed" a Jeep from the Camp motor pool. Another German POW made him some trench art—a small, model boat about 24 inches long—that he has to this day.

Áfter the War, Mr. Angelos earned a degree in Mechanical Engineering from the University of Pittsburgh, graduating at the top of his class. During his career, he worked primarily in the military field, was considered an expert on fuses, and holds 7 U.S. Patents in his name. He was the Program Manager for the M-456 HEAT 105mm artillery round—the precursor to the HEAT round used in today's M1 Abrams tank.

Mr. Speaker, I am humbled and privileged to recognize Mr. Mitchell George Angelos on the great occasion of his 100th Birthday, as well as his tireless and selfless service to our Nation during World War II; truly he is the epitome of The Greatest Generation. His is an example of a "life done right"—as evidenced by a family and many friends who love him dearly, and the countless people whose lives he has affected in myriad ways. He sets the standard by which we all should be judged.

His work with Temple ISD allowed him to advocate for at-risk students, and he later served as District Director for Texas State Senator Troy Fraser. Mr. Brown has also been deeply involved in his community through the Lions Club, Rotary International, and other local service organizations.
