RECOGNIZING THE SUCCESS OF TOM CROWLEY

Mr. FALLON. Mr. Speaker, I rise today to recognize Tom Crowley of Royse City, Texas. Tom Crowley has been a resident of Royse City since 2006 and has dedicated much of his life to public service, community engagement, and leadership. He was first elected to the Royse City Council in May 2010, building on earlier experience serving on the Royse City Zoning Board of Adjustment, as well as similar service in other communities. In 2013, he served on the Royse City ISD Strategic Planning Committee and on the Board of Directors of the Royse City Chamber of Com-

merce. He also chaired the Military Affairs Committee for the San Angelo Texas Chamber of Commerce.

A veteran of the United States Air Force, Tom served 22 years, including 18 years in intelligence, surveillance, and reconnaissance (ISR) collections and analysis platforms. His service took him to eight ground and airborne units across Europe, Asia, the Mediterranean, and the Middle East, as well as two units within the continental United States. He later became a platform instructor, training airmen entering the airborne reconnaissance career field. During his distinguished military career, Tom was awarded the Meritorious Service Medal, eight Air Medals, two Meritorious Achievement Medals, the Combat Readiness Medal, and numerous other decorations. Later in his Air Force career, he cross-trained in journalism, working in public relations and advertising and coordinating with local officials for USAF Thunderbirds aerial demonstration performances.

Tom's commitment to community extends beyond elected office. He is a former member of the Rockwall County Appraisal Review Board, past president of his homeowner's association, and a member of the Royse City chapter of Rotary International. In addition to his civic involvement, Tom spent 26 years in the real estate business, serving on six local Texas Realtor association committees and three statewide committees before retiring from active participation. During a hiatus from real estate, he also served as a law firm area manager for eleven years, overseeing operations across three West Texas counties. Throughout his life, Tom has demonstrated a consistent dedication to improving the communities he serves.

It is my honor to recognize Tom Crowley for his decades of dedicated service to his community, his country, and his family, and for his lasting commitment to strengthening Royse City and Rockwall County.

HONORING COLONEL VŨ VĂN LÔC'S LIFETIME OF SERVICE

Mr. LICCARDO. Mr. Speaker, I rise today to recognize the life and contributions of Colonel Vũ Văn Lộc, a South Vietnamese Army veteran and beloved community leader in San José and the greater Silicon Valley of California, for his unwavering dedication to Vietnamese refugees and cultural perservation—a true model of resilience and service.

From the rice fields of Nam Dinh to the heart of Silicon Valley, Colonel Lôc's journey was extraordinary. Born in 1933 in northern Vietnam, he graduated from the Dá Lat Military Academy and rose through the ranks to serve as a Colonel in the Army of the Republic of Vietnam. When Saigon fell on April 30,

1975, Colonel Lôc and his family were forced to flee their homeland, ultimately finding refuge in San José, California. Rather than succumb to the tragedy of exile, he transformed it into a new mission of hope.

In 1976, soon after arriving in San José, Colonel Lộc founded the Immigrant Resettlement & Cultural Center (IRCC) to aid fellow refugees in rebuilding their lives. Over the next four decades, the IRCC became a lifeline for thousands of Vietnamese, Cambodian, and Laotian families. Colonel Lộc and his team provided English classes, job training, housing assistance, and citizenship guidance to more than 20,000 refugees in Northern California. Under his leadership, the center also fostered cultural and civic events like the annual Tết Lunar New Year festivals, helping new immigrant preserve their cherished traditions as they integrated into American life.

In addition to addressing immediate resettlement needs, Colonel Lộc then started preserving the historical heritage of his people. He began collecting donated mementos that reflected the diverse experiences of Vietnamese refugees, from veterans who had fought alongside him, to boat people who survived harrowing ocean escapes, to those who endured brutal "re-education" camps after the war. Over three decades, Colonel Lôc assembled these artifacts and stories, determined to create an enduring home for the history of the Vietnamese diaspora. That vision culminated in the establishment of the Museum of the Boat People and the Republic of Vietnam, better known simply as the Việt Museum, which opened in San José's History Park in 2007. Housed in a restored historic building, the museum contains hundreds of precious artifacts, photographs, and works of art that tell the story of American journey. The museum would not have come together without immense personal sacrifice from Colonel Lộc who even mortgaged his family home to sustain the museum during difficult times. Thanks to his dedication, the Việt Museum stands today as a treasure of San José, educating future generations about the courage, sacrifice, and contributions of Vietnamese refugees.

Colonel Vũ Văn Lộc passed away peacefully on November 29, 2025, at the age of 92, surrounded by his loved ones and honored by a grateful community. For all of his military rank and community titles, he most cherished his role as a loving husband, father, and grandfather. While Colonel Lôc's journey began in war and exile, it became our community great fortune that he made his second home in San José, and that we could come to know Colonel Vũ Văn Lộc as a friend, mentor, and leader. Today, we honor his memory, and his legacy, which lives on in the hearts of more than 20,000 immigrant Americans who he supported in their brutally difficult journey, and whose journey itself has become an inspiration for our Nation.

Eric began his service with the City of Hayward in 1999, where he rose through the ranks, serving as Firefighter, Captain, Battalion Chief, and Deputy Chief of Special Operations, prior to his current assignment as Interim Fire Chief. His leadership, professionalism, and dedication have left a lasting impact on the department and the residents it serves.

Before being promoted to management, Eric dedicated ten years as a member of the Local 1909 Executive Board, including four years as President, where he advocated for firefighters and worked collaboratively to strengthen labormanagement relations.

Among his proudest accomplishments is his time in the Training Division, where he managed three recruit academies and helped shape the next generation of firefighters. Eric also worked to introduce local youth to the fire service through a partnership with the Eden Area ROP First Responder Program, expanding access and opportunity for students interested in public safety careers.

Eric played a critical role in renewing the department's Critical Incident Stress Management program, ensuring firefighters had the support they needed during challenging moments. During the COVID-19 pandemic, he also managed the Hayward Emergency Operations Center, providing steady leadership during an unprecedented public health crisis.

INTRODUCTION OF THE MARI-JUANA IN FEDERALLY ASSISTED HOUSING PARITY ACT

Ms. NORTON. Mr. Speaker, today, I introduce the Marijuana in Federally Assisted Housing Parity Act. This bill would permit the use of marijuana in federally assisted housing, including public housing and Section 8 housing, in compliance with the marijuana laws of the state (including the District of Columbia) where the property is located. Senator CORY BOOKER is introducing the companion bill.

Individuals living in federally assisted housing should not be denied admission, or fear eviction, for using a product that is legal in the state where they reside. Adult-use marijuana, medical marijuana or both are currently legal in 40 states, the District of Columbia and three territories, and approximately 90 percent of Americans support legalized medical marijuana. Under federal law, users of drugs that are illegal under federal law, including marijuana, are prohibited from being admitted into federally assisted housing. Moreover, federal law allows landlords to evict residents of federally assisted housing for using illegal drugs.

The federal government has begun to change its approach to marijuana. For example, for the last several years, Congress has prohibited the Department of Justice (DOJ) from using federal funds to prevent jurisdictions from implementing their medical marijuana laws. This bill would similarly allow individuals to use marijuana in federally assisted housing in compliance with a state's marijuana laws. The Department of Housing and Urban Development (HUD), like DOJ, should not be allowed to interfere with jurisdictions implementing their marijuana laws.

Under this bill, HUD must develop regulations that restrict smoking marijuana in federally assisted housing in the same manner and in the same locations as HUD restricts smoking tobacco in federally assisted housing.

I urge my colleagues to support this bill.
