RECOGNIZING THE PASSAGE OF THE WOUNDED KNEE SACRED SITE AND MEMORIAL ACT

Mr. JOHNSON of South Dakota. Mr. Speaker, I rise today to recognize and commend the unanimous passage of the Wounded Knee Massacre Memorial and Sacred Site Act in the U.S. House of Representatives and U.S. Senate.

This legislation represents an important step toward preserving one of the most tragic and painful sites in our Nation's history, as we prepare to commemorate the 135th anniversary of the Wounded Knee Massacre on December 29, 1890. The land at Wounded Knee bears witness to the massacre of hundreds of Lakota men, women, and children on December 29, 1890. For generations, this ground has held deep spiritual and historical significance for the Lakota people, and it deserves to be protected and honored accordingly.

In 2023, I had the opportunity to visit the site of the Wounded Knee Massacre, where I met with descendants of survivors and saw firsthand the remnants of that tragic day, including the bloodstained floorboards of St. John's Church where the wounded were treated. That experience underscores the responsibility we share as a Nation to acknowledge our past wrongdoings and ensure that such a

tragedy is never forgotten.

This bill was developed in close partnership with the Oglala Sioux Tribe and the Cheyenne River Sioux Tribe, whose leadership and guidance were essential in shaping legislation that respects tribal jurisdiction and the sacred nature of the land. I am grateful to President Frank Star Comes Out of the Oglala Sioux Tribe and Chairman Ryman LeBeau of the Cheyenne River Sioux Tribe for their continued collaboration and advocacy to preserve the memory and legacy of their ancestors.

Mr. Speaker, on the 100th anniversary of the massacre, Congress issued a formal apology, expressing deep regret for the actions of the federal government and acknowledging the historical significance of this event. As descendants prepare to remember the lives lost on the 135th anniversary, the House and Senate have reaffirmed our commitment to reconciliation and remembrance by passing the Wounded Knee Massacre Memorial and Sacred Site Act unanimously, and I was honored to lead this legislation that preserves the sacred ground and respects the legacy of the Lakota people.

At the time of his retirement, Master Sergeant Smith serves as an MC-130J Special Missions Aviator/Tactician assigned to the 193d SOS in Middletown, Pennsylvania. As a Special Missions Aviator Tactician in the Squadron Tactics office, he advises squadron aviators on the tactical employment of the MC-130J and related mission sets, ensuring mission readiness. His duties include managing the Drop Zone Control and Malfunction offices and the Joint Airdrop Inspectors program that monitors all airdrop inspections and supplies for mission success.

Master Sergeant Smith has deployed in support of myriad missions, including Operations Southern Watch, Desert Strike/Desert Fox, Noble Eagle, Enduring Freedom, New Dawn, Unified Response, Unified Protector, Odyssey Dawn, Inherent Resolve, and Freedom's Sentinel.

medical services (EMS) profession who dedicate their lives to providing often lifesaving medical care and transport services to patients as well as entire communities. These health care professionals are on the frontlines of providing vital emergency 9–1–1 and interfacility ambulance services

Every year, the dispatch of an ambulance is the first response to millions of medical emergencies. Often, the survival of a patient is enhanced by the prompt medical attention provided by paramedics and emergency medical technicians (EMTs) prior to the arrival at an emergency department. As a result of the self-less acts of these courageous and devoted professions, the lives of thousands of Americans are saved each year. While these professionals do not expect to receive recognition for their work, they deserve our outmost gratitude.

I would like to highlight a very special group of EMS professionals or "Stars of Life" who were recently honored by the American Ambulance Association. This year, the American Ambulance Association is recognizing 147 Stars of Life—by far the largest number of Stars of Life in the over 25 years of the program.

The American Ambulance Association honors each year those paramedics, emergency medical technicians, dispatchers and other ambulance service personnel who exemplify what is best about the EMS field. The American Ambulance Association has appropriately designated these individuals as "Stars of Life". Past Stars of Life have included paramedics and EMTs who were part of evacuation and response efforts to natural disasters, acts of terrorism and public health emergencies. HONORING COMPTROLLER GENERAL GENE DODARO

Mr. GARCIA of California. Mr. Speaker, I rise to recognize the Honorable Gene Dodaro, the eighth Comptroller General of the United States and head of the Government Accountability Office, Congress's nonpartisan investigatory arm. Mr. Dodaro's fifteen-year term as the Comptroller General ends on December 29 and his service to GAO, Congress, and our Nation has been remarkable.

Mr. Dodaro began his career at GAO more than fifty years ago. During his time as the

head of GAO, Mr. Dodaro has adapted the agency to meet Congress's needs in a time of extraordinary technological change. While maintaining GAO's stringent quality assurance standards, Mr. Dodaro expanded GAO's work to examine how changes in science and technology affect our government's ability to make sure every federal dollar is spent as Congress intends.

A stalwart commitment to GAO's core values of accountability, integrity, and reliability have defined Mr. Dodaro's tenure. During his term as Comptroller General, GAO's work has led to over one trillion dollars in financial benefits.

Mr. Dodaro has testified before Congress more than 200 times. A cornerstone of his work is GAO's "High Risk List," which highlights specific challenges in programs that involve substantial resources and provide critical services to the public.

GAO's real value, however, goes far beyond what any dollar amount can tell us. GAO's value derives from its ability to independently report the facts and speak truth to power.
