INTRODUCTION OF THE THRIFT SAVINGS PLAN EMERGENCY WITHDRAWAL ACT OF 2025

Ms. NORTON. Mr. Speaker, today, I introduce the Thrift Savings Plan Emergency Withdrawal Act of 2025, which would expand the circumstances in which a federal employee recently separated from the federal government can take a penalty-free withdrawal from their Savings Plan (TSP) account. This bill would help former federal employees pay their bills after separation.

First, this bill would allow a penalty-free withdrawal to make up the gap between the interim payments a retiree receives during the period the Office of Personnel Management is calculating the retiree's final annuity and the estimated final annuity. A retiree's interim payment is generally only 60 percent to 80 percent of the finalized net payment. Second, this bill would allow a penalty-free withdrawal if an individual is involuntarily separated from the federal government. In both cases, the maximum withdrawal would be \$100,000. Individuals would be able to make a withdrawal for up to a year after separation and to repay the withdrawn amount within three years to avoid the existing early withdrawal penalty, which is a 10 percent additional tax.

I urge my colleagues to support this bill.

Mr. THOMPSON of Mississippi. Mr. Speaker, I rise today to recognize the Honorable Gene L. Dodaro upon the completion of his term as the eighth Comptroller General of the United States. During his 52 years working at and leading the Government Accountability Office (GAO), Mr. Dodaro has helped root out waste, fraud, abuse, and mismanagement

across the Federal Government. There is no Federal department, agency, or program that has not been made better because of Mr. Dodaro's tireless work on behalf of the American people.

Mr. Dodaro was the first GAO employee to become Comptroller General, and under Mr. Dodaro's 15-year term at the helm, GAO has saved the American taxpayer more than \$1.2 trillion. The Committee on Homeland Security and I have relied on Mr. Dodaro's deep experience and knowledge of Federal programs and operations to shape the Department of Homeland Security and protect civil rights and civil liberties in the post-9/11 era.

The teams at GAO led by Mr. Dodaro have made Americans safer, made their government more responsive, and saved them money. It is because of GAO's audits of Federal Emergency Management Agency (FEMA) grant programs and response efforts that Americans facing natural disasters can rely on FEMA to get them help quickly and effectively. GAO's examination of Federal cybersecurity and information programs helped with the creation and evolution of the Cybersecurity and Infrastructure Security Agency, which helps protect American schools, hospitals, businesses, and critical infrastructure from costly and damaging cyber attacks. GAO's examinations of Department of Homeland Security intelligence and counterterrorism programs helped protect the Nation, strengthen civil liberties, and implement needed reforms to make the country safer for all people. And in 2020. GAO helped Congress uncover that U.S. Customs and Border Protection was using migrant care funds to buy ATVs while children died in custody.

Members of Congress from both parties and across all congressional committees have benefited from Mr. Dodaro's dedication to accountability, efficiency, and management reform. He testified before Congress more than 200 times and helped Congress steer the United States through the global financial crisis. Mr. Dodaro's work with Congress and Presidential administrations helped shape the Digital Accountability and Transparency Act of 2014, the Federal IT Acquisitions Reform Act of 2014, the Fraud Reduction and Data Analytics Act of 2015, and countless legislation that moved through the Committee on Homeland Security as a result of GAO reports and recommendations.

Mr. Dodaro's accolades are known far and wide. He recently received the Association of Government Accountants' (AGA) Lifetime Achievement Award for a Legacy of Service, was inducted into Government Executive's Government Hall of Fame, and received the AGA Chapters Award for Extraordinary Service to the Nation in Advancing Government Performance and Accountability for Over Five Decades. These awards are deserved and will no doubt crowd his shelf full of similar honors for his lifetime of exemplary service to the Nation. Mr. Dodaro, his family and friends, and his alma mater, Lycoming College, should be proud of Mr. Dodaro's accomplishments.

The United States needs more leaders and public servants in the mold of the Honorable Gene L. Dodaro. His steady leadership, forthrightness, and insight will be sorely missed. I congratulate him on the completion of his term of office and look forward to what is in store for the future.

Mr. EMMER. Mr. Speaker, I rise today to honor the contributions of the Norwegian Americans in the 99th Infantry Battalion during World War II. I want to extend my sincerest gratitude to Jon Grunseth for sharing his family's history with us.

2025 marked the 80th anniversary of the end of WWII. The 99th Infantry Battalion, also known as the Norwegian American Ski Battalion, hailed from Minnesota. Rieder Grunseth, a Norwegian born immigrant to Wayzata, Minnesota, dropped out of law school at the University of Minnesota to enlist in the U.S. Army in 1942. As a member of the 99th Infantry Battalion, Rieder Grunseth provided us with these accounts.

The 99th Infantry Battalion, also referred to as the "99th", consisted of mostly Norwegian born men, specially trained in mountain warfare as ski troopers. In 1943, over 70 of these men were recruited by the Office of Strategic Services, the U.S. intelligence agency during WWII, for special operations in the war. The 99th had many great accomplishments during WWII, which led to the Allied powers success. I would like to highlight one of their greatest accomplishments, Operation Percy Red in August 1944. Seventeen of these brave men parachuted into France to help the French resistance liberate the Haut Vienne region from the Nazis. Percy Red was one of the most successful American behind-the-lines actions during the war in Europe. The story further details how these men went on to China and Vietnam in the summer of 1945 to assist the forces of freedom in that part of the world.

Historic events like these are the reason the Allied troops prevailed in WWII. These men served our Nation heroically, and we as Americans are sincerely grateful for it. Their sacrifices will never be forgotten.

He served as President of the Virginia Baptist State Convention, fostering unity among churches, mentoring faith leaders throughout Central Virginia and beyond, and advancing the mission of service throughout the Commonwealth. He also served as Chairman of the Board of Trustees of Richmond Virginia Seminary and as a trustee of the University of Lynchburg. In these roles, he helped guide institutions dedicated to theological education, leadership development, and community empowerment. Dr. James further shared his wisdom as an adjunct professor and lecturer at institutions including Virginia Union University and Richmond, Virginia Seminary, mentoring future ministers and leaders. He also served as a member of the Virginia Parole Board.

Ďr, James's ministry extended across Virginia and beyond, including earlier service in Chicago and pastoral leadership in Kilmarnock, Petersburg, and Prince George County. Wherever he served, he was known for his steady leadership, deep faith, and unwavering commitment to justice and compassion.
