The team went on to serve as captain of a three-team alliance, selecting partners from India, Canada, and Michigan. They then went against the 5th seeded alliance and won with a score of 228–227.

In addition to their success in Houston, the Warbots had an extremely successful regional competition season. In January, FIRST released this year's challenge, "Reefscape," prompting teams to design, build, and automate their robots in under two months. During District Competitions in March and District Championships in early April, Team 620 captured the Excellence in Engineering Award and the Autonomous Award. Their alliance won the Alexandria event and earned the highest score of the year in the FIRST Chesapeake District.
