A site that serves as a testament to the resilience and contributions of migrant laborers and their profound impact on our Nation's agricultural history.

The Rio Vista Farm was established in 1915 as El Paso County's "Poor Farm" and has served various purposes over the years. From 1951 to 1964, it functioned as a key hub for the Bracero Program, facilitating over 4.6 million border crossings for Mexican agricultural workers under challenging conditions. In recognition of its national significance, the Rio Vista Farm was designated a National Historic Landmark by the U.S. Secretary of the Interior in December 2023. This designation highlights the contributions of Latino excellence and presence in our Nation's history and our community.

As we celebrate National Historic Preservation Month, let us reflect on the importance of preserving our Nation's diverse history and the importance of it. The Rio Vista Farm serves as a powerful reminder of the contributions of migrant laborers and their stories.

I commend the City of Socorro, the National Trust for Historic Preservation, and all involved in these preservation efforts. By working together, we can preserve the culture and heritage of the Rio Vista Farm and the Braceros across the country.

She is also a member of the Phi Theta Kappa Honor Society.

In 2017, Ms. Pryor assumed the role of Assistant Economic Development Director for

Quitman County, where she made significant contributions to the county's financial advancement. Her strategic initiatives and resource-seeking efforts were pivotal in achieving improvements through effective networking and grant writing at the regional, state, and federal levels

In 2021, Ms. Pryor was appointed to the Board of Trustees for Northwest Community College. She has also served as a board member for Mid-State Opportunities and has been actively involved in the Mules & Blues Festival and the Mule Train Historical Society.

Ms. Pryor is the youngest Black woman to serve as the County Administrator in Quitman County. Her responsibilities encompass overseeing and managing the county's budget, marketing strategies, and operational and property functions.

Under her leadership, the Eden United Church of Christ has provided sanctuary to immigrants and has coordinated interfaith accompaniment ministry with asylees, including unaccompanied immigrant youth and children from Central America, Mexico, and Colombia. During the COVID–19 pandemic, Reverend Arlene worked to coordinate Eden's meal program to continue serving its community, many of those who relied on public schools that were closed for their breakfasts and lunches.

As Reverend Arlene enters retirement, I reflect on her career with immense gratitude for all that she did to serve our community over the last 23 years. I wish Reverend Arlene and her spouse, Stephanie, rest, relaxation, and the best of luck in this new chapter of their lives.

RECOGNIZING DR. HUU VO

Ms. TORRES of California. Mr. Speaker, I rise today to recognize the 75th birthday of Dr. Huu Vo and his 50 years of service to the Inland Empire, our Nation, and beyond.

Dr. Vo has led a life of service to his community. He was born on April 4, 1950, in Hue, Vietnam, and in 1968, he graduated valedictorian from Hue National High School. Following his graduation, he attended medical

school in Saigon. While in medical school, he founded and became President of the Association of Hue Students, eager to connect with others from his hometown. Additionally, he volunteered with the Vietnamese Red Cross, leading him to assist refugees in the ongoing war after becoming an accredited doctor.

On April 29, 1975, shortly after graduating from medical school, Dr. Vo fled by Navy Ship to escape communist rule, and on May 15, he arrived at the Guam Orote Point Refugee Camp where he volunteered as a physician at the Army hospital. A month later, he served at Camp Pendleton and eventually settled in Gardena, California.

In 1976, he passed the Educational Commission for Foreign Medical Graduates. Before his eager return to the medical field, he worked a multitude of jobs: as a counselor for the Los Angeles Unified School District, as a clerk at the Alpha Beta Supermarket, as an instructor for a nursing assistant class, and as an Administrator for the Comprehensive and Training Act Program at the Gardena Community Center.

In 1980, after completing his medical residency at the University Hospital in Jacksonville, Florida, Dr. Vo returned to California and treated people at Lanterman State Hospital in the Department of Developmental Services. He worked there as a physician, Chief Medical Staff, and as the Coordinator of Medical Services.

In May of 1982, Dr. Vo joined Pomona Valley Hospital and a medical practice in Pomona. His involvement in our community has been vital not only through his medical expertise but also through his volunteer work and engagement with Pomona's Vietnamese community

munity.

Dr. Vo has been a dedicated and active member and leader of our local Pomona community. He has served as the Board Director of both the Red Cross of Pomona and the YMCA, and as a Board Member of Cal Poly's National Youth Program and Pomona's Growth and Development Group. He also contributed to Police Chief Wood's Police Department Advisory Board.

Additionally, Mr. Vo is admired for his strong engagement with the Vietnamese community of Pomona Valley where he has served as a Board Member, President, and Advisor, before becoming Vice President of the Vietnamese Community of Southern California. In 1992, he founded the Vietnamese American Community of USA, where he later was a Co-Chair, Chairman of the Board of Supervisors, President, and currently serves as an Advisor. In 2016, Dr. Vo founded and co-chaired the United Council of Vietnamese Homeland and Overseas (UNCVHO). For the past six years, he has been the President and Co-Chair of UNCVHO.

Dr. Vo has been recognized by fellow members of the Ametican Medical Association, the American Academy of Family Physicians, and the American Board of Physician Specialists for his remarkable accomplishments. He has been awarded the Distinguished Humanitarian Award and the Lifetime Achievement Award from Marquis Who's Who In America. Additionally, he was in the Global Directory of Who's Who as the Top Doctor of 2013.
