He received advanced artillery training and was awarded for his courage and three Bronze Star Medals, a Purple Heart, and two Army Commendation Medals.

Before returning home, he joined his father, Saint Jameson, in the construction business. When his father retired, Charles took over his role, eventually rising to the position of Project Superintendent and later construction manager. After nearly four decades in the field, he retired in 2010.

In retirement, Mr. Jameson redirected his time and energy into meaningful community service, becoming a driving force behind numerous local initiatives. He worked closely with fellow Carver High School alumni on scholarship programs, served on the boards of the Carver 4-County Museum and the Museum of Culpeper History, and played an active role in organizations such as the Carver Agriculture Research Board, the Culpeper Minutemen, the National Association for the

Advancement of Colored People (NAACP), and the Veterans of Foreign Wars (VFW).

He also holds a leadership position in the local chapter of the Sons of the American Revolution, where he helps organize Culpeper's annual July 4th Patriotic Presentation—an event that honors the region's rich historical legacy. His extensive service and leadership have earned him numerous accolades, including the Culpeper Colonel Award, the MLK Dreamkeeper Award, Aging Together's 5 Over 50 Award, the NAACP Activism Award, and the Neighborhood Watch Amazing Citizen Award.

He was affectionately known as "Mr. Loquacious". Willie was a staunch supporter of the William H. Spencer High School Alumni Association and the Class of 1970 and never missed the activities surrounding the Spencer-Carver sports rivalry events.

Throughout his elementary and secondary education, Willie excelled in athletics. He played baseball, basketball, and ran track for the William H. Spencer Greenwaves. At the age of 10, he started to caddy at the Columbus Lions Club Golf Course on Victory Drive where he learned to play and developed a lifelong love of the game of golf.

Upon graduating from high school, Willie attended Morristown College in Tennessee on a basketball scholarship. He later served in the United States Army and following his discharge returned home to Columbus and entered the insurance profession as a salesman with Life of Georgia Insurance Company and Interstate Insurance company. He became a life underwriter and instructor, teaching classes to prepare countless insurance professionals for certification and licensure.

With his life-long friend from BTW Apartments, Jerome Humphries, golf became a passion. Watching legendary African-American golfers such as Charlie Sifford, Jim Thorpe, Pete Brown, Jim Dent and Bobby Stroble, as caddies on the segregated "Chitlin" golf circuit, they developed skills and ultimately competed professionally on the all black North American Golf Association Tour, traveling through Georgia, Alabama, Florida, North Carolina and South Carolina. They also competed locally in the WOKS Pro-Am Golf Classic, the Purple and Gold Pro-Am Golf Classic and the Victory Drive Golf Classic, Moreover, Willie Watkins and Jerome Humphries founded the Metro Columbus Golf Association in 1987 and promoted charity golf tournaments in support of sickle cell and epilepsy research for the benefit of humanity.

While Willie was well-known for his loquacious personality and sometimes boisterous demeanor, he was a man of deep faith and was an active member of the Fourth Street Missionary Baptist Church from childhood up through the remainder of his life.

On a personal note, Willie was my friend for over 30 years. He was invaluable in his support of the Annual Sanford Bishop Golf Classic for 27 years in both Albany and Columbus. His extraordinary volunteer service contributed mightily to its enduring success. Often Willie and Jerome Humphries traveled with me to play in numerous charity golf tournaments. It was my honor for him to join me in traveling to Augusta National to witness the 2018 Master's which we enjoyed immensely. I will be forever grateful for his friendship and support.

Willie accomplished much in his life but none of it would have been possible without the grace of God and the love and support of his late wife, Patricia D. Watkins; his four children, Marcus Watkins, Willena Watkins Sin-

gleton, Mactrice Watkins Thomas and Willie Watkins, Jr.; his late siblings, Lily Watkins Hopson, Catherine Watkins Jackson, Frank Watkins and Geneva Watkins Burns; his surviving siblings, Ann Watkins Cobb and Jessie Watkins, Jr.; his 8 grandchildren, 2 greatgrandchildren; nieces, nephews, and extended family. CONDEMNING THE VIOLENT JUNE 2025 RIOTS IN LOS ANGELES, CALIFORNIA

Ms. McCOLLUM. Mr. Speaker, I rise in strong opposition to H. Res. 516, the Con-

demning the violent June 2025 riots in Los Angeles, California. It is deeply unfortunate that instead of working with Democrats on a bipartisan resolution to condemn violence, Republicans have instead written a partisan resolution designed to attack elected officials in California. Furthermore, the resolution fails to recognize the premature and escalatory deployment of the National Guard and active-duty Marines by President Trump to Los Angeles.

When the House of Representatives passes a resolution regarding current events, it should do its due diligence to cite the facts. Unfortunately, it is clear the Republican majority had no interest in accurately portraying the protests in Los Angeles when they wrote H. Res. 516. Instead, the resolution perpetuates a false narrative about Democratic elected officials in California. H. Res. 516 states that local elected officials did not adequately respond to the bad actors and trouble-doers. These claims are patently false. Mayor Karen Bass of Los Angeles implemented a multi-day curfew and surged law enforcement resources to downtown Los Angeles to maintain control of the situation. This kept the situation contained to 10 blocks of the downtown area.

But even when the Los Angeles Chief of Police stated that the demonstrations "were nowhere near a level" where the National Guard was needed, President Trump disregarded his opinion and took the escalatory action of deploying 2,000 members of the California National Guard to Los Angeles. Then, on June 10, the President deployed 700 active-duty Marines. Our active-duty military has absolutely no legal role in domestic law enforcement. Los Angeles County has 17,000 law enforcement personnel who are well trained in crowd control. There was no need for the National Guard or the Marines to be deployed by the President, and his decision sets a dangerous precedent for the future.

Republicans had the opportunity to bring a resolution introduced by my colleague, Representative BARRAGÁN, condemning violence and bad actors, and thanking local law enforcement for their work. Instead, Republicans chose to use the unrest in Los Angeles to play partisan games and attack Democrats in California

Mr. Speaker, it is our duty as public servants to tell the truth. We should all stand for condemning violence, de-escalation of force, and the right to peacefully protest. It is unfortunate that this resolution walks away from these principles. I cannot support it.
