Pursuant to clause 7 of Rule XII of the Rules of the House of Representatives, the constitutional authority for enacting the Foreign Anti-Digital Piracy Act is found in Article I, Section 8 of the United States Constitution, specifically.

Clause 3 (Commerce Clause): Congress has the power "To regulate Commerce with foreign Nations, and among the several States, and with the Indian Tribes." This bill regulates digital piracy by targeting foreign websites engaged in large-scale copyright infringement, which impacts interstate and international commerce.

Clause 8 (Copyright Clause): Congress has the power "To promote the Progress of Science and useful Arts, by securing for limited Times to Authors and Inventors the exclusive Right to their respective Writings and Discoveries." This bill protects copyright holders from foreign digital piracy operations that threaten their exclusive rights.

Clause 18 (Necessary and Proper Clause). Congress has the power "To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers." This bill establishes enforcement mechanisms necessary to uphold Congress's authority under the Commerce and Copyright Clauses
