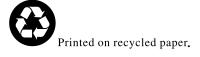

STATE OF CALIFORNIA DECISION AFFECTS STUDENT-ATHLETES

(Mr. KILEY of California asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. KILEY of California. Mr. Speaker, I feel compelled to call attention to an outrageous action that has just been undertaken by the State of California to deprive many, many young people in my district of athletic opportunities.

Truckee Unified School District, which is in my district, competes when it comes to athletics in a neighboring school district in Nevada. What is the reason for that?

Well, for sports like soccer, these are winter sports in California, but they are quite hard to play in the winter in this part of the State because there is a lot of snow. They are spring sports in Nevada. So in order to allow young people to play soccer and other sports, they compete in Nevada.

### BENJAMIN GUERRERO-CRUZ IS HOME

Ms. RIVAS. Mr. Speaker, for months I have been sharing the story of Benjamin Guerrero-Cruz, a constituent of mine who is a senior in high school. He was detained by ICE in August while walking his dog.

In the span of 24 hours, ICE shuffled Benjamin between detention centers and across State lines without his family knowing. I visited Benjamin at the Adelanto Detention Center and observed a recent court hearing of his, and my team has been working with his family on this case throughout the ordeal

Today, I am excited and relieved to report that after months of living through a nightmare, Benjamin is home. My heart goes out to his family, especially his mother, who can hold her son again after months of fear and uncertainty at the hands of ICE. No family should ever have to live through this

I will continue showing up to detention facilities to hold ICE and this administration accountable for the terror that they are forcing families to live through each day.

Mr. Speaker, I am glad that Benjamin is home, and I hope he and his family can begin the healing process.

Welcome home, Benjamin.

CONDEMNING THE ILLEGAL EFFORTS TO DISMANTLE THE DEPARTMENT OF EDUCATION

Ms. McBRIDE. Mr. Speaker, I rise today to condemn the Trump administration's illegal efforts to dismantle the Department of Education.

The President and the Secretary of Education can call this plan whatever they want, but the bottom line is that this is about defunding public education and putting taxpayer dollars into the hands of private institutions who do not face the same standards and protocols as public schools.

The Department of Education protects students with disabilities, supports rural and low-income schools, and helps make college more affordable for students across the country.

In Delaware, \$530 million in Federal education funding supports teachers across our State. Removing that funding would mean students without teachers, schools without support, and communities left behind.

I have stood arm in arm with Delaware educators, parents, and students who are pushing back. They are asking for a fair shot, and we should be investing in their future, not abandoning them.

HONORING THE LIFE AND COURAGE OF RALPH LAWRENCE CARR

(Mr. TAKANO asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. TAKANO. Mr. Speaker, I rise today to honor the life and courage of Ralph Lawrence Carr, the 29th Governor of Colorado, whose birthday we celebrate today.

He was in office when Executive Order 9066 was issued, the order that permitted the mass incarceration of 120,000 Japanese Americans, including my grandparents and parents during World War II.

A staunch Republican, he refused to comply with the order and instead opened the State of Colorado to Japanese Americans fleeing the Federal Government. To a group of farmers concerned with his support of Japanese Americans, Governor Carr said, "An American citizen of Japanese descent has the same rights as any other citizen. If you harm them, you must first harm me."

Mr. Speaker, the Governor lost reelection, largely due to his defense of Japanese Americans. Let his courage be a lesson to us today as we, once again, see a dark tide spread across our country.
