S. 728

At the request of Mrs. GILLIBRAND, the name of the Senator from New York (Mr. SCHUMER) was added as a cosponsor of S. 728, a bill to establish the African Burial Ground International Memorial Museum and Educational Center in New York, New York, and for other purposes.

S. 730

At the request of Mrs. GILLIBRAND, the name of the Senator from New York (Mr. Schumer) was added as a cosponsor of S. 730, a bill to direct the Secretary of the Interior to conduct a study to assess the suitability and feasibility of establishing the African Burial Ground International Memorial Museum and Educational Center at the African Burial Ground National Monument, and for other purposes.

S. 847

At the request of Mrs. BRITT, the names of the Senator from North Carolina (Mr. TILLIS) and the Senator from New Hampshire (Ms. HASSAN) were added as cosponsors of S. 847, a bill to amend the Internal Revenue Code of 1986 to expand the employer-provided child care credit and the dependent care assistance exclusion.

STATEMENTS ON INTRODUCED BILLS AND JOINT RESOLUTIONS

By Mr. REED (for himself, Ms. Collins, Mrs. Shaheen, and Mr. Coons):

S. 1342. A bill to amend the Energy Conservation and Production Act to improve the weatherization assistance program, and for other purposes; to the Committee on Energy and Natural Resources

Mr. REED. Mr. President, today I am introducing the Weatherization Assistance Program Improvements Act, along with Senators Collins, Coons,

and Shaheen. Our bipartisan bill will make critical updates to ensure this important program can effectively serve even more households across the country.

Since 1976, the Weatherization Assistance Program has helped more than 7 million low-income households reduce their energy bills by making their homes more energy efficient. The Department of Energy estimates that these upgrades help each household save \$372 or more in energy bills annually. Those energy savings free up limited financial resources for essentials, like groceries and medicine.

In addition to traditional services like attic and wall insulation, the program also provides services that help with home health and safety measures, such as installing smoke and carbon monoxide detectors. Energy efficient homes also help cut down on our carbon footprint, reducing the greenhouse gas emissions that cause climate change.

An independent study of the Weatherization Assistance Program by Oak Ridge National Laboratory found that children in weatherized households miss less school, improving educational outcomes. Adults miss less work, increasing both their own incomes and their contributions to the economy. Families also reported experiencing fewer flu and cold symptoms and emergency room visits, decreasing costly medical expenses.

The Weatherization Assistance Program also helps boost our economy. The Department of Energy has reported that the program supports over 8,500 jobs while increasing our national economic output by \$1.2 billion per year.

The program is a win-win for all involved. That is why, as a member of the Senate Appropriations Committee, I have led my colleagues in supporting strong funding for it every year. And that is why I am introducing this bill—to ensure it continues to work for years to come.

This bill will help expand the program to many more low-income households that are currently unable to receive weatherization services because their homes need minor structural repairs before they can be weatherized. The bill will authorize a weatherization readiness fund to repair structural issues and prepare homes for weatherization assistance, increasing the number of homes the program is able to serve.

At the same time, it will raise the amount of funding allowed to be spent on each home to keep up with current labor and material costs, and it will raise the cap on the amount of funding allowed to be spent on renewable energy upgrades in each home. These provisions are essential updates to a program that has helped so many families over the past few decades.

I urge my colleagues to join us in supporting this commonsense legislation.

### TEXT OF AMENDMENTS

**SA 2222.** Ms. LUMMIS (for Mr. MORAN) proposed an amendment to the

bill S. 423, to protect regular order for budgeting for the Department of Veterans Affairs, and for other purposes; as follows:

Strike all after the enacting clause and insert the following:

## SECTION 1. PROTECTING REGULAR ORDER FOR VETERANS.

- (a) SHORT TITLE.—This section may be cited as the "Protecting Regular Order for Veterans Act of 2025" or the "PRO Veterans Act of 2025".
- (b) QUARTERLY BRIEFINGS ON DEPARTMENT OF VETERANS AFFAIRS BUDGETARY SHORT-FALLS.—
  - (1) QUARTERLY BRIEFINGS.—
- (A) QUARTERLY BRIEFINGS REQUIRED.—During the first quarter beginning after the date of the enactment of this Act and in each quarter thereafter until the date that is three years after the date of the enactment of this Act, the Secretary of Veterans Affairs shall provide to the appropriate committees of Congress a quarterly briefing, in person, on the budget of the Department of Veterans Affairs and any shortfall the Department may be experiencing.
- (B) PLANS.—In any case in which the Secretary informs Congress during a briefing under paragraph (1) that the Department is experiencing a shortfall, the Secretary shall, during such briefing, present the plans of the Secretary to address or mitigate the shortfall.
  - (2) Definitions.—In this subsection:
- (A) APPROPRIATE COMMITTEES OF CONGRESS.—The term "appropriate committees of Congress" means—
- (i) the Committee on Veterans' Affairs and the Committee on Appropriations of the Senate; and
- (ii) the Committee on Veterans' Affairs and the Committee on Appropriations of the House of Representatives.
- (B) SHORTFALL.—The term "shortfall", with respect to a fiscal year, means that the amount of appropriations required by the Department of Veterans Affairs for such fiscal year to meet all of the statutory obligations of the Department during that fiscal year exceeds the amount of appropriations requested for the Department for that fiscal year in the budget of the President submitted pursuant to section 1105(a) of title 31, United States Code, for that fiscal year.
- (c) LIMITATIONS ON PROVISION OF INCENTIVES FOR CRITICAL SKILLS TO SENIOR EXECUTIVE SERVICE EMPLOYEES OF DEPARTMENT OF VETERANS AFFAIRS.—Section 706(d) of title 38, United States Code, is amended by adding at the end the following:
- "(7)(A) Subject to subparagraph (B)(ii), a critical skill incentive may not be provided under paragraph (1) to an employee of the Department employed in a Senior Executive Service position, or a position in another comparable system for senior-level Government employees, as defined by the Secretary, whose position is at the Central Office of the Department, including the Veterans Health Administration, the Veterans Benefits Administration, and the National Cemetery Administration, regardless of the actual location where the employee performs the functions of the position.

"(B)(i) A critical skill incentive provided under paragraph (1) to an employee of the Department employed in a Senior Executive Service position, or a position in another comparable system for senior-level Government employees, as defined by the Secretary, not described in subparagraph (A) of this paragraph may only be provided—

"(I) on an individual basis and may not be provided to a group of such employees; and

"(II) upon approval of the following officers or those serving in an acting capacity:
