A motion to commit the bill to the Committee on Finance to strike any provision which reduces the average tax liability of individual taxpayers with income in excess of \$100,000,000.

A motion to commit the bill to the Committee on Commerce, Science, and Transportation to ensure that the bill does not result in the movement of any non-Federal users by the Federal Communications Commission or the National Telecommunications and Information Administration into certain specified spectrum frequency bands without prior written approval from the Secretary of Defense.

H.R. 1

Mr. HICKENLOOPER. Mr. President, I ask unanimous consent that the following motions to commit for the bill H.R. 1 be placed in the CONGRESSIONAL RECORD:

A motion to commit the bill H.R. 1 to the Committee on Energy and Natural Resources of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would ensure that any sales of public lands exclude—

(A) land deemed valuable for watershed health;

(B) land used for, or suitable for, hunting, fishing, or recreation;

(C) land with cultural or historic significance;

(D) land with critical wildlife habitat;

(E) land including areas sensitive for reasons relating to national security;

(F) land within the limits of an Indian reservation; and

(G) land over which federally recognized Indian Tribes retain reserved rights, including hunting, fishing, and gathering rights through a treaty, agreement, or Executive order.

A motion to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would strike any provision that cuts funding for Medicaid which covers care for 60 percent of all nursing home residents.

A motion to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would strike any provision that cuts funding for Medicaid and the Affordable Care Act which—

(A) protects access for the 7,000,000 small businesses workers who depend on Medicaid coverage; and

(B) protects access for the 4,000,000 small businesses who depend on the Affordable Care Act exchanges.

A motion to commit the bill H.R. 1 to the Committee on the Judiciary of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would ensure the State of Colorado is included in the definition of 'affected area' in downwind States, due to the catastrophic amounts of radiation exposure in this State after United States testing above ground nuclear weapons during World War II and the Cold War.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would ensure this legislation will not lead to cuts to the Medicare program.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would ensure this legislation will not lead to Medicare sequestration cuts triggered by an increase to the deficit under the Statutory Pay-As-You-Go Act of 2010.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would make changes to ensure that this Act will not cause rural hospitals to close.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would ensure that as a result of the enactment of this bill, no labor and delivery units within hospitals will close.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Agriculture, Nutrition, and Forestry of the Senate with in-

structions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would provide at least \$1,800,000,000 for hazardous fuels reduction projects on National Forest System land within the wildland-urban interface.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) do not include an increase in the statutory limit on the public debt under section 3101 of title 31, United States Code, if the bill would reduce taxes on individuals with an income of more than \$10,000,000 per year.

Motion to Commit With Instructions

Mr. SCHIFF moves to commit the bill H.R. 1 to the Committee on Agriculture, Nutrition, and Forestry of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would ensure that no provision of the bill cuts any food assistance benefits for families with children under the age of 12.

Mr. GALLEG0. Mr. President, I ask unanimous consent that the following motions to commit for the bill H.R. 1 be placed in the CONGRESSIONAL RECORD:

Mr. GALLEG0 moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee;

(2) would provide permanent tax relief on overtime wages to working class Americans; and

(3) would ensure that giant corporations and the ultra-wealthy pay their fair share of taxes.

Mr. GALLEG0 moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee;

(2) would strike any provision that cuts Medicaid payments for substance use disorder treatment; and

(3) would ensure big corporations and the ultra-wealthy pay a fair share in taxes.

H.R. 1

Mr. WELCH. Mr. President, when the Senate considers the reconciliation bill, H.R. 1, it is my intention to make the following motions to commit the bill:

A motion to commit the bill to the Committee on Finance with instructions to maintain the Energy Efficient Home Improvement Credit of section 25G of the Internal Revenue Code of 1986, as it is currently in effect, through December 31, 2028.

A motion to commit the bill to the Committee on Finance to strike any changes to

Medicaid provider tax provisions that impact Medicaid expansion states.

A motion to commit the bill to the Committee on Finance to strike any changes to Medicaid provider tax provisions.

A motion to commit the bill to the Committee on Finance to allow the use of electronic data sources, auto-renewal, and provisional advanced premium tax credits for verification of eligibility with respect to the tax credit allowed under section 36B of the Internal Revenue Code of 1986.

A motion to commit the bill to the Committee on Health, Education, Labor, and Pensions to allow States to determine qualifying events eligible for special enrollment in qualified health plans offered on the American Health Benefit Exchanges.

A motion to commit the bill to the Committee on Finance to exempt managed care programs operated by a State government entity from any changes to State-directed payment.

A motion to commit the bill to the Committee on Finance to strike provisions that negatively impact care provided at rural hospitals or to the fiscal well-being of rural hospitals.

A motion to commit the bill to the Committee on Health, Education, Labor, and Pensions to establish that any Federal student loan payments made during the general forbearance period count towards payment requirements of the public service loan forgiveness program under Section 455(m) of the Higher Education Act of 1965 (20 U.S.C. 1087e(m)).

A motion to commit the bill to the Committee on Agriculture with instructions to strike and SNAP administrative cost-shifts to States.

A motion to commit the bill to the Committee on Agriculture with instructions to make strong investments in organic farmers and businesses, including improvements for the Organic Certification Cost Share Program, support for organic supply chains, improvements in organic data collection, and continued efforts to address fraudulent organic imports and to protect the integrity of the organic seal.

A motion to commit the bill to the Committee on Agriculture with instructions to make changes that would allow volunteer work to qualify as work under work requirements in the Supplemental Nutrition Assistance Program.

A motion to commit the bill to the Committee on Finance with instructions to revise section 48E of the Internal Revenue Code of 1986 to make investments in retrofitting or partially upgrading a qualified facility a qualified investment.

MOTION TO COMMIT WITH INSTRUCTIONS

Ms. BLUNT ROCHESTER moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee;

(2) would strike any provision limiting Medicaid state-directed payments; and

(3) would preserve access to hospital labor and delivery units to protect the 40% of births nationwide and nearly 50% of births in rural communities that are financed by Medicaid.

MOTION TO COMMIT WITH INSTRUCTIONS

Ms. BLUNT ROCHESTER moves to commit the bill H.R. 1 to the Committee on Environment and Public Works of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would require federally funded lead service line removal projects to be completed within 10 years of the date of enactment of that bill.

MOTION TO COMMIT WITH INSTRUCTIONS

Ms. BLUNT ROCHESTER moves to commit the bill H.R. 1 to the Committee on Finance of the Senate with instructions to report the same back to the Senate in 3 days, not counting any day on which the Senate is not in session, with changes that—

(1) are within the jurisdiction of such committee; and

(2) would create an above-the-line tax deduction for primary care, dental, and mental health workers serving in Health Professional Shortage Areas.
