INTRODUCTION OF BILLS AND JOINT RESOLUTIONS

S. 3558. A bill to amend title 18, United States Code, to establish criminal penalties for interfering with National Guard protective zones; to the Committee on the Judiciary.

S. 3559. A bill to designate the community-based outpatient clinic of the Department of Veterans Affairs in San Jose, California, as the "Corporal Patrick D. Tillman VA Clinic"; to the Committee on Veterans' Affairs.

S. 3560. A bill to amend title XVIII of the Social Security Act to provide coverage of contraceptive items and services at no cost-sharing under the Medicare program, and for other purposes; to the Committee on Finance.

By Mr. REED (for himself, Mr. VAN HOLLEN, Mr. BLUMENTHAL, and Mrs. GILLIBRAND):

S. 3561. A bill to amend the Truth in Lending Act and the Consumer Financial Protection Act of 2010 to apply certain protections and oversight to buy now, pay later loans, and for other purposes; to the Committee on Banking, Housing, and Urban Affairs.

By Mr. SCOTT of Florida (for himself and Mr. FETTERMAN):

S. 3562. A bill to require the Securities and Exchange Commission to amend the rules of the Commission relating to disclosures by advisers of private funds, and for other purposes; to the Committee on Banking, Housing, and Urban Affairs.

S. 3563. A bill to require the Secretary of Defense assess and, as appropriate, implement open technical standards for digital content provenance, and for other purposes; to the Committee on Armed Services.

S. 3564. A bill to direct the Secretary of Health and Human Services, acting through the Director of the National Institutes of Health, to take certain steps to increase clinical trial diversity, and for other purposes; to the Committee on Health, Education, Labor, and Pensions.

By Mr. WICKER (for himself and Mrs. CAPITO):

S. 3565. A bill to amend the Infrastructure Investment and Jobs Act to authorize the use of remaining funds under the Broadband Equity, Access, and Deployment Program for competitive subgrants to support the success of the broadband deployment projects funded by that program, and for other purposes; to the Committee on Commerce, Science, and Transportation.

By Mr. SCOTT of Florida:

S. 3566. A bill to withdraw normal trade relations treatment with respect to the Peo-

ple's Republic of China, and for other purposes; to the Committee on Finance.

By Mr. LEE:

S. 3567. A bill to authorize the President of the United States to issue letters of marque and reprisal with respect to acts of aggression against the United States by a member of a cartel, or a member of a cartel-linked organization, or any conspirator associated with a cartel, and for other purposes; to the Committee on Foreign Relations.

By Mr. MARKEY:

S. 3568. A bill to amend the Immigration and Nationality Act to provide individuals approved for naturalization with the right to complete the naturalization process, and for other purposes; to the Committee on the Judiciary.

By Mr. DURBIN (for himself and Mr. TILLIS):

S. 3569. A bill to establish a Federal multi-agency task force to combat illegal importation, distribution, and sale of e-cigarettes; to the Committee on the Judiciary.

S. 3570. A bill to establish duties for online service providers with respect to end user data that such providers collect and use; to the Committee on Commerce, Science, and Transportation.

By Mr. MURPHY (for himself and Mr. SCHIFF):

S. 3571. A bill to limit the authority of U.S. Border Patrol personnel to their traditional border security duties, and for other purposes; to the Committee on Homeland Security and Governmental Affairs.

By Mr. BOOZMAN (for himself, Mr. PADILLA, and Mrs. HYDE-SMITH):

S. 3572. A bill to amend title 23, United States Code, to allow recipients of certain grants to improve highway safety efforts through the integration of predictive data analytics, telematics, and other advanced technologies, and for other purposes; to the Committee on Commerce, Science, and Transportation.

By Mr. LUJÁN (for himself and Mr. HEINRICH):

S. 3573. A bill to amend the Aamodt Litigation Settlement Act to modify a provision relating to the extension of certain dates for the completion of the Regional Water System, and for other purposes; to the Committee on Indian Affairs.

By Mr. SCHMITT:

S. 3574. A bill to prohibit United States courts from recognizing, enforcing, or giving effect to any judgment, order, decree, or provisional measure issued by a court of the People's Republic of China in a proceeding motivated by retaliation for lawful acts, including political speech; to the Committee on the Judiciary.

By Mr. PADILLA (for himself and Mr. CRAMER):

S. 3575. A bill to amend the Federal Credit Union Act to provide for certain ways in which credit unions may be Agent members of the National Credit Union Administration Central Liquidity Facility; to the Committee on Banking, Housing, and Urban Affairs.

By Mr. HICKENLOOPER:

S. 3576. A bill to establish a Commission on the Federal Regulation of Cannabis to study a prompt and plausible pathway to the Federal regulation of cannabis, and for other purposes; to the Committee on the Judiciary.

By Mr. COONS (for himself, Mr. MORENO, and Ms. ROSEN):

S. 3577. A bill to provide funding to State and local law enforcement agencies to com-

bat auto theft and stolen automobile trafficking, and for other purposes; to the Committee on the Judiciary.

S. 3578. A bill to amend the Financial Stability Act of 2010 to require the Financial Stability Oversight Council to consider alternative approaches before determining that a U.S. nonbank financial company shall be supervised by the Board of Governors of the Federal Reserve System, and for other purposes; to the Committee on Banking, Housing, and Urban Affairs.

By Mr. SULLIVAN (for himself and Ms. MURKOWSKI):

S. 3579. A bill to address data and research gaps to improve marine environmental data collection, particularly in the Bering Sea, Aleutian Islands, and Gulf of Alaska, prioritize technology that supports research, bycatch reduction, and marine benthic habitat in Alaska fisheries, advance and streamline electronic monitoring and electronic reporting in United States fisheries, and establish a fund to provide financial assistance for fishermen purchasing gear and technology aimed at reducing bycatch and marine benthic habitat contract from trawl fishing gear; to the Committee on Commerce, Science, and Transportation.

A resolution honoring the service and sacrifice of United States Army Sergeant William Nathaniel Howard and United States Army Sergeant Edgar Brian Torres-Tovar, who were killed in action in Palmyra, Syria, in a targeted assault against United States service members on December 13, 2025; considered and agreed to.

By Mr. RISCH:

S. Res. 573. A resolution expressing the need for the United States' continued leadership on matters of religious freedom; to the Committee on Foreign Relations.

ADDITIONAL COSPONSORS

S. 138

At the request of Mr. SHEEHY, the name of the Senator from Idaho (Mr. RISCH) was added as a cosponsor of S. 138, a bill to require each enterprise to include on the Uniform Residential Loan Application a disclaimer to increase awareness of the direct and guaranteed home loan programs of the Department of Veterans Affairs, and for other purposes.

S. 226

At the request of Mr. SHEEHY, the name of the Senator from Montana (Mr. DAINES) was added as a cosponsor of S. 226, a bill to require a strategy to oppose financial or material support by foreign countries and nongovernmental organizations to the Taliban, and for other purposes.

S. 367

At the request of Mr. DURBIN, the name of the Senator from Maryland (Ms. ALSOBROOKS) was added as a cosponsor of S. 367, a bill to prohibit the importation, sale, manufacture, transfer, or possession of .50 caliber rifles, and for other purposes.

S. 439

At the request of Mr. BUDD, the name of the Senator from Georgia (Mr. OSSOFF) was added as a cosponsor of S. 439, a bill to amend the Internal Revenue Code of 1986 to exclude from gross income gain from the sale of qualified real property interests acquired under the authority of the Readiness and Environmental Protection Integration (REPI) program administered by the Department of Defense pursuant to section 2684a of title 10, United States Code, and for other purposes.

S. 522

At the request of Mr. HAGERTY, the names of the Senator from Georgia (Mr. OSSOFF) and the Senator from New Mexico (Mr. LUJÁN) were added as cosponsors of S. 522, a bill to amend the Federal Credit Union Act to modify the frequency of board of directors meetings, and for other purposes.

S. 526

At the request of Mr. GRASSLEY, the name of the Senator from Georgia (Mr. WARNOCK) was added as a cosponsor of S. 526, a bill to prevent unfair and deceptive acts or practices and the dissemination of false information related to pharmacy benefit management services for prescription drugs, and for other purposes.

S. 646

At the request of Ms. ROSEN, the name of the Senator from Michigan (Ms. SLOTKIN) was added as a cosponsor of S. 646, a bill to prohibit the use of funds to carry out Executive Order 14160.

S. 735

At the request of Mr. SCOTT of South Carolina, the name of the Senator from Georgia (Mr. OSSOFF) was added as a cosponsor of S. 735, a bill to amend the Public Health Service Act to reauthorize a sickle cell disease prevention and treatment demonstration program.

S. 844

S. 900

S. 952

At the request of Mr. CASSIDY, the name of the Senator from Arkansas (Mr. BOOZMAN) was added as a cosponsor of S. 952, a bill to amend the Harmonized Tariff Schedule of the United States to provide a uniform 8-digit subheading number for all whiskies.

S. 1173

At the request of Mr. CASSIDY, the name of the Senator from Tennessee (Mrs. BLACKBURN) was added as a cosponsor of S. 1173, a bill to amend title XVIII of the Social Security Act to clarify and preserve the breadth of the protections under the Medicare Secondary Payer Act.

S. 1191

At the request of Mr. OSSOFF, his name was added as a cosponsor of S. 1191, a bill to amend the National Environmental Policy Act of 1969 to require the Council on Environmental Quality to publish an annual report on environmental reviews and causes of action based on alleged non-compliance with that Act, and for other purposes.

At the request of Mr. KING, the name of the Senator from Georgia (Mr. OSSOFF) was added as a cosponsor of S. 1217, a bill to amend the Farm Credit Act of 1971 to support the commercial fishing industry.

S. 1324

At the request of Mr. OSSOFF, his name was added as a cosponsor of S. 1324, a bill to amend the Safe Drinking Water Act to modify eligibility for the State response to contaminants program, and for other purposes.

S. 1329

S. 1478

S. 1664

At the request of Mr. OSSOFF, his name was added as a cosponsor of S. 1664, a bill to require the Director of the Office of Science and Technology Policy to develop a consistent set of policy guidelines for Federal research agencies to address financial instability of graduate researchers and postdoctoral researchers, and for other purposes.

S. 1666

At the request of Mr. GRASSLEY, the name of the Senator from Georgia (Mr. WARNOCK) was added as a cosponsor of S. 1666, a bill to amend title VII of the Social Security Act to provide for a single point of contact at the Social Security Administration for individuals who are victims of identity theft.
