Also, a memorial of the Legislature of the State of Texas, relative to House Concurrent Resolution 13, urging the federal government to take immediate action to curb the spread of the New World screwworm into Texas, including using existing resources to work with Mexico to further develop a plan to combat screwworms; jointly to the Committees on Agriculture, Energy and Commerce, and Armed Services.
