AUTHORIZING THE USE OF EMANCIPATION HALL IN THE CAPITOL VISITOR CENTER FOR A CEREMONY AS PART OF THE COMMEMORATION OF THE DAYS OF REMEMBRANCE OF VICTIMS OF THE HOLOCAUST

Mrs. MILLER of Illinois. Mr. Speaker, I ask unanimous consent that the Committee on House Administration be discharged from further consideration of H. Con. Res. 72, and ask for its immediate consideration in the House.

The SPEAKER pro tempore. Is there objection to the request of the gentleman from Illinois?

The text of the concurrent resolution is as follows:

H. CON. RES. 72

Resolved by the House of Representatives (the Senate concurring),

SECTION 1. USE OF EMANCIPATION HALL FOR A CEREMONY AS PART OF THE COMMEMORATION OF THE DAYS OF REMEMBRANCE OF VICTIMS OF THE HOLOCAUST.

(a) AUTHORIZATION.—Emancipation Hall in the Capitol Visitor Center is authorized to be used on April 14, 2026, for a ceremony as part of the commemoration of the days of remembrance of victims of the Holocaust.

(b) PREPARATIONS.—Physical preparations for the ceremony described in subsection (a) shall be carried out in accordance with such conditions as the Architect of the Capitol may prescribe.

The concurrent resolution was agreed to.

MAKING IT HARDER FOR U.S. CITIZENS TO VOTE

(Mr. LANDSMAN asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. LANDSMAN. Mr. Speaker, I rise today because the House just voted on the SAVE America Act, which will make it harder for tens of millions of Americans to vote, not noncitizens. Noncitizens can't vote. They can't register to vote. If they do, they will be deported.

American citizens are being denied their right to vote by requiring, in this bill, all kinds of paperwork to register, all kinds of paperwork to vote.

Three examples: For married women, there are 70 million women with an ID that does not match their birth certificate. It will be harder for them to register to vote. Seniors, especially those who have been voting by mail, it will be harder for them to vote. College students and those who serve our country abroad would have to come home in order to register to vote.

This is a terrible, un-American, undemocratic, honestly insane bill that the Senate should not take up.

HONORING SARAH ROOT

(Mr. FEENSTRA asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. FEENSTRA. Mr. Speaker, I rise today to honor Sarah Root and express the relief of our community that justice has been delivered to her killer.

In 2016, 21-year-old Sarah Root was driving home from her graduation

when an illegal immigrant, who was drunk, driving at three times the legal limit, struck and killed her. Her killer posted bail and vanished from the country, leaving Sarah's family without answers for nearly 10 years.

Sarah should be 31 today. In her memory, I fought to pass Sarah's Law, included in the first bill signed by President Trump.

Her bill is now law, and on February 3, justice finally came for her killer. He was extradited, convicted, and sentenced to more than 20 years in prison.

As a father of two girls, I cannot fathom the pain Michelle and Scott have endured the past 10 years. Sarah's Law is a promise to them and every American family that we will not ignore these tragedies, and we will act to prevent them.

RECOGNIZING BRADLEY SOLYAN

Ms. LOIS FRANKEL of Florida. Mr. Speaker, I rise today with great gratitude for my chief of staff, Bradley Solyan, who is departing my office after 12 years of extraordinary service to the people of Palm Beach County and our country.

Brad really has quite a story. He came to Washington having been a teacher in south Florida, and then he joined my office as an intern. He became the legislative correspondent, policy adviser, legislative director, and, ultimately, chief of staff—what a role model for perseverance and dedication.

He has led with vision, patience, and a steady hand. No matter the challenge, he has always been calm, with clarity and focus. Best of all, he comes to the office every day with a very big smile, and he lifts us all.

Mr. Speaker, I am going to miss Brad dearly. I wish him great success, and I ask everybody to join me in wishing Brad great success on his new journey.

HONORING YVONNE FEDDERSON

(Mr. BIGGS of Arizona asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. BIGGS of Arizona. Mr. Speaker, I rise in honor of Yvonne Feddersen, co-founder of Childhelp, a national organization dedicated to the prevention and treatment of child abuse.

Yvonne lived an amazing, divinely inspired life.

In 1959, Yvonne was in her mid-twenties and in the midst of a successful acting career. She and Sara O'Meara, who became a close friend and cofounder of Childhelp, were on a USO tour in Japan when they found 11 Japanese-American orphans kicked out of their orphanage. Yvonne and Sara responded, finding them shelter and long-term care.

What started as an effort to help these 11 children turned into a lifelong calling. Yvonne and Sara went on to open orphanages in Japan and Vietnam, saving tens of thousands of children.

In the mid-1970s, at the behest of Nancy Reagan, they opened their first iteration of Childhelp in California. They have since created a nationwide network of assistance, including a 24/7 hotline, treatment centers, abuse prevention programs, and awareness campaigns. We are honored that they chose to headquarter Childhelp in Arizona.

On January 23 of this year, at the age of 90, God called Yvonne home. I count it as a tremendous blessing to have known Yvonne and witnessed the profound impact she had on the lives of our most vulnerable, on our community, our State, and our Nation. Her legacy will endure.

HONORING FIREFIGHTER HOWARD BENNETT

Mr. NORCROSS. Mr. Speaker, I rise today to recognize Howard Bennett, a Camden City, New Jersey, firefighter who tragically lost his life on the job last week.

Firefighter Howard Bennett served with integrity, humility, and heart. Today, I honor his service and extend my deepest condolences to his loved ones. May he rest in peace.

HOUSING FOR THE 21ST CENTURY
